2 A MOTION setting the date of hearing on the  
3 Reassessment and to confirm the Revised Assessment  
4 Roll for King County Road Improvement District No. 75

5 WHEREAS, King County Road Improvement District No. 75  
6 ("RID 75") was established by King County Ordinance No. 3242  
7 passed by the King County Council on June 6, 1977, to provide  
8 for improvements to a portion of South West 336th Street and  
9 South West 340th Street in the Woodridge Park area of King  
10 County; and

11 WHEREAS, the original assessment roll for RID 75 was con-  
12 firmed by King County Ordinance No. 4894 passed by the King  
13 County Council on May 19, 1980, after construction of the  
14 improvement project had been completed, and after a public  
15 hearing on May 19, 1980 for the purpose of considering the  
16 assessment roll; and

17 WHEREAS, certain statutes of the State of Washington in  
18 effect at the time of the creation of RID 75 limited the  
19 interest rate which could lawfully be levied on RID assessments  
20 and made it impracticable to issue and sell revenue bonds to  
21 finance said improvements, and such statutes have since been  
22 amended; and

23 WHEREAS, the Director of the Department of Public Works has  
24 determined the total to be reassessed against all parcels in  
25 RID 75 to be \$244,912.97; and

26 WHEREAS, the Director of the Department of Public Works has  
27 prepared and filed with the Clerk of the Council a revised  
28 assessment roll setting forth that portion of the total costs  
29 and expenses of accomplishing the improvement project which are  
30 to be reassessed against the property within RID 75, and the  
31 amount to be assessed against each parcel therein;

32 NOW, THEREFORE, BE IT MOVED by the Council of King County:

SECTION 1: The Council hereby states its intention to hold a public hearing pursuant to RCW 36.88.090 for the purpose of considering the revised assessment roll for RID 75 which is on file with the Clerk of the Council. Said hearing is scheduled for January 31, 1982, at 9:30 A.m., in Room 402 of the King County Courthouse.

SECTION 2: At the hearing, the Council will sit as a board of equalization for the purpose of considering the revised assessment roll, and will consider such written objections as are made thereto, or any part thereof, and will correct, revise, raise, lower, change, or modify the revised roll or any part thereof. Or, the Council may set aside said roll and make the assessments de novo so that they are just and equitable, and then proceed to confirm the same by ordinance.

SECTION 3: The Clerk of the Council is hereby directed to give notice of the public hearing by mailing and publication at the times and in the manner set forth in RCW 36.88.090, in accordance with RCW 36.88.100 and 35.44.350.
