2 A MOTION authorizing the King County Executive to enter
3 into and execute a mutual assistance and interlocal
4 agreement among King County municipal corporations for the
5 purpose of providing fire control, fire prevention,
6 emergency medical services and other emergency support in
7 the event of a major fire, medical or related disaster.

8 WHEREAS, there are many governmental entities in King County which have
9 responsibility for the control of fire, fire prevention, emergency medical
10 services and other emergency support within their specified political boun-
11 daries, and

12 WHEREAS, King County government is responsible for: (1) organizing,
13 administering, and operating the King County Emergency Operations Center, (2)
14 preparing disaster and emergency response plans, including the King County
15 Emergency Services Operations Plan, (3) providing public safety services in
16 unincorporated King County, (4) investigating fires of suspicious origin in
17 unincorporated King County, (5) administering the emergency medical services
18 program and providing paramedic services in certain areas of King County, and
19 (6) providing Enhanced 911 emergency telephone service throughout King County,
20 and

21 WHEREAS, there may arise from time to time major fire and medical
22 disasters within a given jurisdiction or overlapping jurisdictions where
23 mutual assistance between or among governmental entities in King County may be
24 desirable or necessary, and

25 WHEREAS, it would be of benefit to King County to have a mutual
26 assistance and interlocal agreement in place in the event such disasters do
27 occur, and

28 WHEREAS, King County government may enter into and execute mutual
29 assistance and interlocal agreements with other King County municipal cor-
30 porations for reciprocal emergency assistance where a disaster is too great to
31 be dealt with unassisted, and

32 WHEREAS, the King County Fire Chief's Association on June 15, 1983
33 adopted a proposed mutual assistance and interlocal agreement for the purpose
of providing fire control, fire prevention, emergency medical services and
other emergency support in the event of a major fire, medical or other related

1 disaster, which is in accord with the general requirements of the King County
2 Emergency Services Operations Plan;


3 NOW, THEREFORE BE IT MOVED by the Council of King County:

4 A. Pursuant to RCW 39.34.080, and RCW 38.52.070, the King County
5 Executive is authorized to enter into and execute the proposed mutual
6 assistance and interlocal agreement adopted by the King County Fire Chiefs
7 Association for the purpose of providing fire control, fire prevention,
8 emergency medical services and other emergency support in the event of a major
9 fire, medical or related disaster.


10 B. The mutual assistance and interlocal agreement shall be included as
11 part of the King County Emergency Services Operations Plan.
