A MOTION certifying that the extension of Metro's North Lake Sammamish Interceptor by the City of Redmond is conditionally consistent with King County land use plans and policies as required by Metro Resolution 2933 and county Ordinance 4226.

WHEREAS, Metro Resolution 2933 Section 3-02 requires land use certification by King County of proposed extensions of Metro facilities, and

WHEREAS, on February 6, 1985, Metro requested King County certification of the proposed extension of the North Lake Sammamish Interceptor, and

WHEREAS, the proposed Interceptor extension has been reviewed by the King County department of planning and community development which has prepared a report (attached) recommending conditional approval of this extension, and

WHEREAS, this proposed extension has a potential service area that is outside the existing Local Service Area and,

WHEREAS, King County Ordinance 4226 specifies that the King County council may grant or deny certification;

NOW, THEREFORE BE IT MOVED by the Council of King County:

The extension of Metro's North Lake Sammamish Interceptor by the City of Redmond is hereby certified as consistent with King County land use plans and policies as required by Metro Resolution 2933 and King County Ordinance 4226, provided that no sanitary sewer connections be allowed outside the current Local Service Area.

A MOTION certifying that the connection of sanitary sewer to Metro's North Lake Sammamish Interceptor by the City of Redmond is consistent with King County land use plans and policies as required by Metro Resolution 2933 and county Ordinance 4226.

WHEREAS, Metro Resolution 2933 Section 3-02 requires land use certification by King County of proposed connections to Metro facilities, and

WHEREAS, on February 5, 1985, Metro requested King County certification of the City of Redmond's connection of the North Lake Sammamish Interceptor, and

WHEREAS, the proposed connection has been reviewed by the King County department of planning and community development which has prepared a report (attached) recommending approval of this connection, and

WHEREAS, King County Ordinance 4226 specifies that the King County council may grant or deny certification;

NOW, THEREFORE BE IT MOVED by the Council of King County:

The proposed connection of a twenty four or thirty inch sanitary sewer by the City of Redmond to Metro's North Lake Sammamish Interceptor is hereby certified as consistent with King County land use plans and policies as required by Metro Resolution 2933 and King County Ordinance 4226.
