A MOTION approving the King County Centennial Commission's goals and criteria for funding and endorsing programs and projects; and authorizing the King County Executive to spend \$6,000 for a feasibility study of a Washington State History Event, and \$19,000 for Bicycle Event project and Centennial Map.

WHEREAS, the county council by Ordinance No. 8331
appropriated \$250,000 with up to \$50,000 of that amount allocated to heritage grant projects, for centennial program projects, and WHEREAS, the county council by a proviso to Ordinance No.

8331, Section 80, required the centennial commission to submit for council approval funding and endorsement criteria, and

WHEREAS, the county council also required the centennial commission to submit for approval expenditure proposals, and

WHEREAS, the centennial commission has adopted and submitted funding and endorsement criteria for council approval, and

WHEREAS, the centennial commission has identified three major projects of county-wide significance it wishes to proceed with immediately;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

- A. The King County council approves the attached centennial commission goals and criteria for funding and endorsement of programs and projects.
- B. The county executive is hereby authorized to spend up to \$6,000 for the centennial program to allow a feasibility study of a Washington State History Exhibit.

GOALS FOR FUNDING AND ENDORSING PROGRAMS AND PROJECTS

The Centennial Commission would like to encourage a diversity of Centennial projects and programs that will leave lasting legacies of tangible and visible products for our residents, our visitors and future generations. The Commission will look for innovative and exemplary projects that support the centennial goals and enhance the celebration in new and creative ways.

Projects may focus on celebrating the heritage of our past, the present, or the promise of the future and shall be for non-profit purposes.

A balance of projects will be considered relating to a spectrum of interests including such areas as heritage, maritime, the arts, ethnic groups, recreation, education, civic and beautification activities and economic development.

Preference will be given for projects which demonstrate broad community. support and provide opportunities for maximum participation in the implementation phase. Upon completion, the project must be accessible to participation by all without discrimination of any kind.

The Commission will put particular emphasis on projects which enable us to appreciate our County in new ways and knit us together as a region.

A portion of the funding available will be reserved for projects of "county-wide" significance. The remaining funds will support local projects reflecting the unique character and interests of King County communities.

All applicants must be individuals, groups, non-profit organizations or local units of government. Applicants must demonstrate fiscal responsibility and an ability to successfully complete the project. Finally, all projects must be completed by the end of the State Centennial Year 1989.

All projects located within an incorporated city or town shall have a 33% match, which may be cash and/or an in-kind contribution.

All County, state and federal laws concerning non-discrimination shall apply.

FUNDING AND ENDORSEMENTS OF PROGRAMS AND PROJECTS

Programs and projects will be initiated by Committees as well as other organizations and communities. The standing Centennial Committees will review all proposals and make recommendations to the full Commission for approval. In the event a project is not recommended, an appeal process to the full Commission will be provided for.

Funding and endorsements of projects will be considered in the following three categories:

- I. Projects of County-wide significance half revenues will be set aside for this category.
- II. Local Community significance half of revenues will be set aside for this category.
- III. State Funding Process:

projects of State-wide significance - endorsement optional

Rainier Bank VISA - endorsement required - 10 only from King County
