A MOTION for the King County Council to set a date for a hearing for the proposed creation of a Flood Control Zone District - Horseshoe Lake, King County, Washington.

MOTION NO.

WHEREAS, a flood control zone district is needed to correct the existing problems caused by inadequate and unmaintained drainage systems, compounded by flooding from the Snoqualmie River, and

WHEREAS, it is also necessary to develop a long-range comprehensive plan for storm water control, and

WHEREAS, this area is not within the Surface Water Management Service Area which means it is ineligible for revenue from this program to correct drainage problems, and

WHEREAS, a petition has been filed with the King County council requesting the creation of a flood control zone district in the Horseshoe Lake area, and

WHEREAS, the Manager of the division of records and elections has determined that said petition has been signed by owners of an aggregate amount of the majority of the area within the limits of the district to be created, as required by R.C.W. 86.15.020, and

WHEREAS, it is hereby found that said petition is sufficent and that the proposed district is sufficiently developed;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

It is the intention of the council to establish a flood control zone district, pursuant to the aforesaid petition and pursuant to Chapter 153, Section 2, of the Regular Sessions Laws of 1961 and R.C.W. 86.15.020 to include all property in the drainage basin lying within a certain described area as follows:

At such time and place, the council intends to hear such objectors and testimony and to act on the intention to form a Flood Control Zone District.

The clerk of the council is hereby authorized and directed to give notice of said public hearing by publication described in RCW 36.32.120(7) and a notice of the public hearing will be mailed to the owners of property which comprise the proposed Horseshoe Lake Flood Control Zone District.
