A MOTION requesting the Boundary Review Board to review the City of Des Moines proposed annexation "Northwest Des Moines" pursuant to RCW 36.93.100.

WHEREAS, the Boundary Review Board (BRB) was created to provide a neutral forum for the public hearing and the review and determination of proposed annexations and incorporations to avoid competition to extend municipal boundaries, to prevent the haphazard boundary extensions, and to create and preserve logical service areas as set forth as purposes and objectives of the BRB in RCW 36.93.010 and RCW 36.93.180, and

WHEREAS, coordination between jurisdictions and examination of service issues should be encouraged, and

WHEREAS, the city of Des Moines on July 11, 1989 filed a notice of intention to annex an area known as Annexation "Northwest Des Moines", and

WHEREAS, the legal description overlaps with Normandy Park and creates a small unincorporated island, and

WHEREAS, RCW 36.93.100 provides for the BRB to review proposed annexations, and King County Ordinance No. 8389 provides for a means of requesting such review, and

WHEREAS, the public is best served by open public hearing and review of these issues;



The Washington State Boundary Review Board for King County is requested to review the following specific action:


