WHEREAS, the King County Prosecutor's Office reviewed the petitions identified in Attachment A and saw no legal impediment to granting these refunds on the council's own motion.


WHEREAS, pursuant to RCW 84.69.030, the council may act upon its own motion to grant these refunds;

NOW, THEREFORE, BE IT MOVED by the Council of King County:


