A MOTION requesting the Executive to submit recommendations and an action plan for council review and approval to comply with the Americans with Disabilities Act of 1990.

WHEREAS, the County is already working to comply with Section 504 of the Rehabilitation Act of 1973, as amended, which bans the exclusion of persons with disabilities, as defined in the Act, from participation in programs and activities receiving federal funding, and

WHEREAS, the County Council adopted Motion 7160 establishing an advisory committee to draft a compliance plan relative to Section 504, and

WHEREAS, the County Council authorized and funded a position in the Department of Executive Administration to actively monitor compliance with Section 504, and

WHEREAS, the County Council adopted Motion 7670 adopting a 504 compliance workplan and adopted Ordinance 9383 establishing a permanent 504 advisory committee, and

WHEREAS, President Bush recently signed into the Americans with Disabilities Act of1990 known the as "Emancipation Proclamation" for persons with disabilities extending federal protection to persons with disabilities in private employment settings, public services, transportation, public accommodations, and telecommunications services, and

WHEREAS, the federal government must promulgate rules and regulations by 1992 to begin implementation of the new law, and

WHEREAS, it is the goal of King County government to make its own facilities and programs accessible to persons with disabilities, and

WHEREAS, the King County Code protects persons with disabilities against discrimination in employment, public accommodations and housing;
