MOTION NO. 8092

A MOTION authorizing the county executive to amend a grant application authorized by Motion #8055 to request State Department of Ecology Centennial Clean Water Program funds to support creation of sewage treatment facilities plans for several Vashon Island communities.

WHEREAS, the County council has approved Motion #8055 authorizing the executive to submit a grant application for funds in the approximate amount of \$23,246 to support creation of sewage treatment facilities plans to address a severe health hazard in the Vashon Island communities of Beulah Park/Cove and Spring Beach, and

WHEREAS, the recently completed Vashon sanitary survey conducted by the Seattle-King County department of public health has identified two additional communities, Bunker Trail and the village of Burton, which are sufficiently impacted by inadequate on-site sewage disposal systems so as to merit recommendation by the county health officer for designation as severe public health hazard areas, and

WHEREAS, designation of these two communities as severe public health hazard areas by the State Department of Health is now pending, and

WHEREAS, the public health hazards are the most serious problems attributable to inadequate sewage systems discovered by the Seattle-King County department of public health during the Vashon sanitary survey, and

WHEREAS, the sewage disposal problems encountered have a community-wide impact and are not resolvable by performing individual residential sewage system repairs due to very unfavorable site conditions, and

WHEREAS, the affected communities are outside any sewer district service area, and

WHEREAS, the total funding being requested from the State Department of Ecology is being increased from \$23,246.00 to \$51,267.50, and

WHEREAS, the council recognizes an obligation to provide the amount of \$20,535 in-kind contribution and \$30,733 cash in 1991, and

WHEREAS, the State Department of Ecology has recommended that the grant application be amended to include the two additional communities;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

A. The King County executive is hereby authorized to make amended grant application to the State Department of Ecology for funds in the approximate amount of \$51,267 to support development of sewage treatment facilities plans for the Vashon Island communities of Spring Beach, Beulah Park/Cove, Bunker Trail and the village of Burton.

B. The King County executive is hereby authorized to file and execute such contracts as are required by the grantor;

C. The King County executive is also authorized to enter into and execute such subcontracts as are necessary for the implementation of the project;

D. The Department of Ecology is hereby assured full compliance with Title VI of the Civil Rights Act.
