

MOTION NO. **8361**

A MOTION supporting the Open Space Citizen Oversight Committee's recommendation for allocation of conservation futures levy proceeds to suburban cities for the purpose of providing funding for open space acquisition activities.

WHEREAS, R.C.W. 84.34.230 grants counties the right to levy a property tax for the purpose of acquiring conservation futures in real property, pursuant to R.C.W. 84.34.210 and R.C.W. 84.34.220, and

WHEREAS, by ordinance, conservation futures levy proceeds are collected by King County, and

WHEREAS, Ordinance 8867, as amended by Ordinance 9430 (codified in K.C.C. 26.12) establishes King County's policies and procedure regarding distribution of conservation futures levy proceeds to incorporated cities, and

WHEREAS, Ordinance 9128 appropriates funds for incorporated cities to use for open space acquisition and related expenses, and

WHEREAS, K.C.C. 26.12 directs the open space oversight committee to review and make recommendations to the executive on all requests for conservation futures levy proceeds, and

WHEREAS, the open space citizen oversight committee has reviewed requests from several cities;


NOW, THEREFORE, BE IT MOVED by the Council of King County:

A. The King County council hereby approved the allocation of conservation futures levy proceeds to the projects and in the amounts listed in Attachment A.


B. The executive is authorized to enter into and execute contracts and interlocal agreements that may be necessary for the distribution of these funds.
