A MOTION approving the appointment of citizens to serve on the ARCH Citizen Advisory Board.

WHEREAS, in February 1993 the King County council approved Motion 8957 confirming a slate of candidates to the Citizen Advisory Board of A Regional Coalition for Housing (ARCH), and

WHEREAS, the primary responsibilities of the Citizen Advisory Board are to provide recommendations to the ARCH Executive Board on land and/or money resource allocations and to provide public relations and educational outreach services, and

WHEREAS, two new members are needed to replace departing members, and

WHEREAS, the two new proposed members have been screened and interviewed by the Executive Board of ARCH, and

WHEREAS, the proposed candidates have been forwarded by the Executive Board of ARCH for approval by the King County council;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The two individuals listed in Attachment A are appointed to the Citizen Advisory Board for ARCH according to the terms of the interlocal cooperation agreement.

## ITEM: ARCH CITIZEN ADVISORY BOARD MEMBERS

**Background:**

In the past few months, two members of the ARCH Citizen Advisory Board (CAB)- Terry Kalet and Karen Reed- have retired from the CAB because of changes in their personal lives. At its September and October meetings, the Executive Board interviewed two perspective replacements for the vacated positions. In considering these replacements, the Executive Board made it a priority to find replacements with attributes and skills similar to those of Terry and Karen. Terry was a member of several community commissions in Kirkland, and Karen is an attorney.

The Executive Board adopted motions to approve the nominations of Michael Lyons and Judith Bigelow and to forward these nominations to the member jurisdictions councils for their review and approval.

Michael Lyons is a resident of Kirkland, and a member of the Kirkland Growth Management Commission. He is also a member of the Kirkland Alliance of Neighborhoods, and Kirkland Business Improvement District. Professionally, he has extensive experience in community planning and real estate development. His development experience is in both the public and private sectors, and he is currently Development Manager for SunCrest Homes, a local single family builder. His interest in joining the CAB include assisting with specific projects that combine the resources of the lending, development and public sectors, and assisting with a public information program to increase community awareness and communication among the various entities involved in affordable housing.

Judith Bigelow is a resident of Yarrow Point, and an attorney with Preston Thorgrimson Shidler Gates and Ellis. She is a member the firm's real estate department and her clients typically are institutional and individual real estate investors. Judith has been a member of the Yarrow Point Planning Commission since 1991 and was named Chair in 1993. She has participated in Seattle's Leadership Tomorrow program. Her other community activities include being on the board of the Committee for Children, and providing legal assistance to the Community Psychiatric Clinic when they have acquired housing for their clients. Ideas identified by Judith promoting community involvement, encouraging the participation of the private sector to provide affordable housing, and funding innovative and sound affordable housing projects.

**Recommended Action:**

Approve the nominations of Michael Lyons and Judith Bigelow to the ARCH Citizen Advisory Board.
