2 A MOTION approving modifications to the schedule
3 for preparing the 1994 update to the King County
4 Comprehensive Plan, to allow additional time for
5 public review, and requesting the King County Executive
6 to notify the Washington State Department of Community
7 Development of the revised schedule, and to report back
8 to the Council on progress of public review before
9 transmittal of the Executive Proposed King County
10 Comprehensive Plan.

11 WHEREAS, the Washington State Legislature has extended the deadlines for
12 adopting comprehensive plans imposed by the Growth Management Act (GMA) as
13 they relate to collecting impact fees from new development, and

14 WHEREAS, the original scheduled transmittal date of April 12, 1994 for
15 the Executive Proposed King County Comprehensive Plan and Draft Environmental
16 Impact Statement (EIS) would provide only limited time for public comment
17 before the council begins its review, and

18 WHEREAS, Countywide Planning Policies are required by the GMA to serve as
19 a framework for local comprehensive plans, but the original schedule would not
20 allow review of revised Countywide Planning Policies before council's review
21 of the Executive Proposed Comprehensive Plan, and

22 WHEREAS, revisions to the Countywide Planning Policies are scheduled to
23 be adopted by the King County council in July, 1994, and

24 WHEREAS, additional preparation time for the Executive Proposed Compre-
25 hensive Plan will allow more time to incorporate citizen and stakeholder
26 comments, and therefore will facilitate timely review of the proposal by the
27 King County council;

28 NOW, THEREFORE, BE IT MOVED by the Council of King County:

29 A. The King County executive is hereby requested to transmit to the
30 council a proposed update to the King County Comprehensive Plan by July 1,
31 1994, and to complete preparation of a Draft Environmental Impact Statement,
32 in accordance with the schedule shown in Attachment A.

33 B. The King County executive is hereby requested to notify the
Washington State Department of Community Development of this schedule.

1 C. The King County executive is hereby requested to provide regular
2 reports to the council during public review prior to transmittal of the Execu-
3 tive Proposed King County Comprehensive Plan to the council.
