MOTION NO. 9360

A MOTION authorizing the executive to submit applications and accept grants offered by the U.S. Department of Transportation, Federal Transit Administration, and to execute grant pass-through agreements with state and local jurisdictions.

WHEREAS, the Secretary of the U.S. Department of Transportation is authorized to make grants for mass transportation projects (hereinafter "projects") under the Federal Transit Act, as amended, and

WHEREAS, the grant contracts for financial assistance will impose certain obligations upon the county, including the local share of project costs, and

WHEREAS, it is required by the U.S. Department of Transportation in accordance with the provision of Title VI of the Civil Rights Act of 1964, as amended, that the county give assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder, and

WHEREAS, it is the goal of the county that certified disadvantaged business enterprises be used to the fullest extent possible in connection with said projects and that such certified businesses shall have the maximum feasible opportunity to participate in the performance of contracts for materials, equipment and supplies and in providing consultant or construction services for and to the county, and

WHEREAS, the county, on behalf of state and local jurisdictions, will be applying for Federal Transit Administration assistance funds for projects which will require the execution of grant pass-through agreements with said jurisdictions;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

1 A. The county executive or his designee is hereby
 2 authorized to execute and file applications with the Federal
 3 Transit Administration of the U.S. Department of Transportation
 4 to aid in the financing of federally programmed projects
 5 contained in the adopted budget or in long range plans.

6 B. The county executive or his designee is hereby
 7 authorized to execute and file such application assurances or
 8 other documents required by the U.S. Department of
 9 Transportation to effectuate the purposes of Title VI of the
 10 Civil Rights Act of 1964.

11 C. The county executive or his designee is hereby
 12 authorized to furnish such additional information as the U.S.
 13 Department of Transportation may require in connection with
 14 applications for projects including, but not limited to,
 15 affirmative action and disadvantaged business policies
 16 applicable to project procurement needs.

17 D. The county executive or his designee is hereby
 18 authorized to accept and execute grant contract agreements with
 19 the Federal Transit Administration of the U.S. Department of
 20 Transportation for aid in financing of federally programmed
 21 projects contained in the adopted budget or long range plans.

22 E. The county executive or his designee is hereby
 23 authorized to execute pass-through agreements with state and
 24 local jurisdictions, said agreements to be in such form as may
 25 be approved by the prosecuting attorney's office.
