H. F. Lee was born in Shanghai, China, raised in Taiwan and is now a naturalized U.S. citizen. He was trained as an electrical engineer and has a BSEE degree from National Taiwan University and a MSEE degree from University of Washington. He joined The Boeing Company in 1965 and has done avionics design and development work on a number of airplane programs, such as B737, 747, 757, 767, 777, and 7J7. His current assignment is the senior manager of functional test engineering for B747, 767, and 777, working at the Everett plant.

He and his wife Diane have three grown children. They have lived in the King County since 1961 and in Bellevue since 1968. In addition to his busy work schedule, he has been active in carrying out his civic duty. He has urged Asian Americans to join in the main stream society and to participate in the American political process. He has taken part in many local campaigns to support candidates and issues. Some of his involvements are:

- is board member of Kin-on Nursing Home in Seattle.
- was president of Chinese American Association for Professionals in 1986 & 1987. Organized and chaired large conferences on technical and social issues with international speakers.
- was president of Seattle Chinese Engineers Society in 1973. Promoted the technical excellence of Chinese American engineers.
- was one of the founders of the Chinese Community Public Affairs Organization in early 70's. Promoted the awareness and participation of the political process.
- rallied different factions of Chinese Americans to raise funds for Senator Slade Gorton. Member of his state advisory committee.
- organized a group of local businessmen to join Senator Gorton to visit Taiwan in 1989.
- Campaigned and raised funds for State Rep and King County Executive Gary Locke.
