- 4. Problem-solving role: In recent years, the problem to be solved was how best to make a living from farming on Vashon. My wife and I tried several approaches (cut flowers, retail craft sales at the farm, gourmet salad business to wholesale customers) and after analysis plus experience chose to retail a broad mix of edibles directly to consumers via subscription farming. In earlier years, my formal training (B.S. in Engineering, West Point; MBA, Darfmouth) and over 20 years business/military experience (6 years military, 4 years Ford Mo. Co., 5 years public utility, 5 years small business executive or owner, 2 years medical center facilities management) involved constant and substantial problem solving.
- 5. Changing one's mind with new information: Data obtained from agricultural periodicals and conferences led us to change from frequent deep tillage to mulching and shallow tilling as a better way to improve production and long term soil health.
- 6. Why serve on Commission? We left other successful careers in '87-'88 to pursue a passionate interest in farming. As natives, we chose to do it in this area. We believed that there were ways to succeed close to urban areas, and selected an old farm that allowed several options. It is now clear, after 7 years experience, that the Community Supported Agriculture type farm can be successful on a very small piece of property, and indeed is probably the best hope to continue agriculture in King County. Our farm, and the several others like it nearby, can be a model for a resurgence of numerous financially successful small farms on the urban fringe. This kind of non-capital intensive farming operation is one of the few bright spots in an otherwise often-gloomy industry. I want to share and encourage this vision of a new-old style of agriculture that is good for the land, the local economy, the health of local residents, and potential family farmers, and is ideally suited for King County.
