
QUALIFICATIONS:

1. I am co-owner of one of the few "Centennial" farms in King County. (farm has been continuously in our family for over one-hundred years.) We are currently raising beef cattle.
2. I retired with thirty years of service as a food safety officer with the Washington State Department of Agriculture.
3. I have a working knowledge of food safety issues including the use of pesticide chemicals.
4. I have experience in writing rules to implement state legislation.
5. I co-authored a report to the legislature on Food Transportation Hazards.
6. I worked on policy advisory committees involving members from Federal, State and County Government.
7. I prepared and gave oral presentations to industry, consumer and government groups.
8. I gave training presentations to new employees .

SPECIAL INTERESTS:

1. Formation of reasonable policies that will encourage and allow agriculture to co-exist with the growing urbanization of King County.
2. Policies that will encourage agriculture to provide open space, animal habitat, wetlands, forest lands and recreational opportunities.
3. Encourage the development of local marketing and processing of King County agricultural products.
4. Develop policies that minimize stream degradation from agricultural activities, but will be flexible enough to allow appropriate agricultural activity near wetlands if adequate controls are implemented.
5. Promote low input, sustainable agriculture in King County.
6. Discourage and reduce the use of pesticide chemicals and excessive fertilizer by industry, agriculture, golf courses and home owners.
7. Provide incentives to salvage and market animal manure products for use by local landscapers and residents.

I am currently a retired state employee, working on my farm and doing consulting work for food processing companies on a part-time basis. I am available to attend meetings, even on short notice.

1992-1993 Worked on food inspection programs and policy development; gave training presentations to new personnel and made food inspection training videos. I researched emerging issues for the Assistant Director and did staff work for the Food Safety Enhancement Advisory Committee. I gave new employees specialized field training, and gave oral presentations to various government and industry groups. I worked on writing rules for regulating bottled water products and for imposing civil penalties for certain violations of laws. I summarized and presented cases regarding violations of food laws to the Assistant Attorney General.

1990-1991 I co-authored a report to the Legislature on Food Transportation hazards. I was Chairman of the Bulk Food Transportation Safety Advisory Committee and worked on writing rules to regulate bulk food transportation. I worked with new employees and assisted food safety officers on violative inspections.

1979-1990 I supervised four to six food safety officers in the Food Inspection program and did inspection work statewide including grain elevators, flour mills, bakeries and food warehouses.

1964-1979 I worked as a food inspector specializing in seafood and low acid canned food products.
