
A MOTION confirming the Executive's reappointment of Don Haldeman to the King County Board of Appeals and Equalization.

BE IT MOVED by the Council of King County:


The county executive's reappointment of Don Haldeman to the King County Board of Appeals and Equalization, term to expire on June 30, 1999, is hereby confirmed.
