7 1996 election the voters approved the formation of the  
8 Issaquah Library Capital Facility Area (the "Area") and the  
9 issuance of bonds to finance library facilities; and,

10 WHEREAS, RCW 27.15.030 requires that the Area have a  
11 governing body consisting of three members of the county  
12 legislative authority to be appointed by a majority of the  
13 full county legislative authority; and

14 WHEREAS, the councilmembers representing those  
15 geographic areas either within or most directly affected by  
16 the Area and its proposed facilities should participate in  
17 its governance; and

18 WHEREAS, it is most appropriate that the chair of the  
19 governing body of the Area be the councilmember within whose  
20 district the Area is located;
