A MOTION appointing the Issaquah Library Capital Facility Area governing body pursuant to RCW 27.15.030.

WHEREAS, pursuant to RCW 27.15.020, at the November 5, 1996 election the voters approved the formation of the Issaquah Library Capital Facility Area (the "Area") and the issuance of bonds to finance library facilities; and,

WHEREAS, RCW 27.15.030 requires that the Area have a governing body consisting of three members of the county legislative authority to be appointed by a majority of the full county legislative authority; and

WHEREAS, the councilmembers representing those geographic areas either within or most directly affected by the Area and its proposed facilities should participate in its governance; and

WHEREAS, it is most appropriate that the chair of the governing body of the Area be the councilmember within whose district the Area is located;
