A MOTION approving landmark restoration projects for the Arts and Natural Resources Initiative-Suburban Arts and Heritage Projects in accordance with Ordinance 11578.

WHEREAS, a review panel of historic preservation professionals reviewed the applications and made recommendations to the King County landmarks and heritage commission as listed in Attachment A, and

WHEREAS, the recommendations for stabilization projects funding adhere to the guidelines approved by the King County council in Motion 9514, and

WHEREAS, notice and public hearing are required before allocation of monies for landmark stabilization projects that are intended to be reimbursed by proceeds of bonds to be issued by King County;

King County Landmarks and Heritage Commission LANDMARK RESTORATION GRANT PROGRAM RECOMMENDATIONS

Overview

The Landmarks and Heritage Commission recommends allocating remaining funds from the 1995 Arts and Heritage Initiative—Landmark Restoration Grant program to the three properties identified below based on a competitive application process.

The recommended projects represent the fourth round of funding in the Landmark Restoration Program, adopted by the King County Council in 1995. In this funding round, landmark owners whose buildings had been designated as King County or interlocal city landmarks since the previous grant round in July, 1997 were eligible to apply. The Commission prioritized funding for stabilization and restoration projects which would spur economic development and be a model for historic restoration. The Landmarks and Heritage Commission received five applications for grant funds, requesting a total of \$165,462.

The Design Review Committee of the King County Landmarks and Heritage Commission met on April 14, 1998 to review the applications. For the grant review, Design Review Committee members Pat Fels and Julie O'Neil were joined by architect David Leavengood of Leavengood Architects. Landmark and Heritage Program staff Clo Copass and Julie Koler were also present.

The review committee focused on the following criterion in evaluating the applications: projects contribution to restoration goals for the property or the historic district; contribution of the proposed project to remedying deteriorated physical conditions which, if left untreated, will hasten the deterioration of the Landmark and result in higher long-term restoration costs. Additionally, the panel considered whether the applicant provided a credible project cost estimate, a detailed project description, and the extent of the owner's financial participation in the project.

The panel recommends disbursing the \$48,632 available as outlined below:

PROJECTS RECOMMENDED FOR FUNDING

1. Applicant: Adam and Jane Dopps

Landmark: Skykomish Hotel, Skykomish

Project Budget: \$36,278 Requested: \$28,550

Recommended award: \$23,000

Project Summary: Funds were requested to replace a failing septic system. If the system ceases to function, the hotel and restaurant will have to close. If they are closed for more than 90 days, they will be required to bring all building systems up to code.

Comments: The committee thought that the applicant had established the urgent need to complete this project. They noted that this was an unexpected setback for the owners, who had purchased the building just last year. The panel noted that the system was highly complex, due to the nature of the use of the building and the constraints of the site itself, which is relatively small and located near the Skykomish River

2. Applicant: Unity Lodge No. 198, F&A.M Landmark: North Bend Masonic Hall

Project Budget: \$44,910 Requested: \$39,010 Recommended award: \$15,000

Project Summary: Funds were requested to remove the Alpine false front, replace and/or repair second story front windows as needed; repair roofing where Alpine false work is removed; repair aluminum store front as needed; repair exterior concrete wall; paint and/or seal concrete wall; remove existing signage and replace with neon signage and painted window signs. Additionally, funds were requested to repair, paint and/or seal exterior walls, and create new painted signage on the east and west walls.

Comments: The panel noted that this building is very prominent in North Bend, and that a successful facade restoration will demonstrate to other property owners that the rehabilitation of their historic structures is a viable alternative to the continued utilization of the Alpine motif. The panel decided to focus on funding for the facade, rather than the other elevations of the building.

3. Applicant: Susan and Dale Sherman

Landmark: Sherman Tile, Snoqualmie Historic Commercial District

Project Budget: \$40,736 Requested: \$37,902 Recommended award: \$10,632

Project Summary: Funds were requested to reconstruct the facade of the building. The proposal submitted included building a new foundation, demolishing the upper facade, canopy, doors, and foundation, and rebuilding the front facade, replacing floor joists, building a new store front with new double-pane windows, new doors, and new siding. The plans also include a new metal canopy. This is the third phase of a major building remodel. The owners have already completed work on the rear elevation and interior, including the structure.

Comments: The panel noted that the owners have already completed significant work on the building as phase I and II of the project, and that this project will play a key role as a model for storefront restoration.

Project Summary: Funds were requested to remove existing marquee and replace with a new canopy, replace the roof, repair siding, replace gutters, and paint exterior.

Comments: While the panel felt that the proposed work would have a positive impact on the historic district, the panel was concerned about the lack of a detailed project description or prioritization of the requested elements as part of a preservation plan.

2. Applicant: Catherine Randleman

Project Summary: Funds were requested to repair the roof and foundation, and install a new canopy on the front of the building.

Comments: The panel was concerned by the lack of a detailed project description or prioritization of the requested elements as part of a preservation plan.
