KING COUNTY CHILDREN AND FAMILY COMMISSION FUNDING POLICIES BACKGROUND INFORMATION

FAMILY SUPPORT PROGRAM SAFE COMMUNITIES/YOUTH PARTNERSHIP PROGRAM HEALTHY FAMILIES/EARLY CHILDHOOD PROGRAM

General Background

The King County Children and Family Commission (CFC) acts in an advisory capacity to the King County Executive and King County Council, focusing on recommendations to further define King County's mission, role, and goals in provision of services to children and families.

One role of the CFC is to assist the County in creating new approaches to services in partnership with families and their communities. The CFC provides technical assistance and limited funding for development and improvement of services through demonstration projects.

Since its inception in 1992, the CFC has developed three major program areas for demonstration projects: Family Support Program, Safe Communities/Youth Partnership Program, and Healthy Families/Early Childhood Program. The CFC has written a comprehensive funding policy for each program. The funding policies address funding criteria; process for funding; and funding beyond the demonstration phase.

<u>Demonstration Projects (Family Support and Safe Community/Youth Partnership</u> <u>Programs</u>) -- Currently, Family Support and Safe Communities/Youth Partnership projects are ending the third year of funding (1996-1998). All projects are demonstration projects. The new funding policies will address funding beyond the demonstration phase for all future projects.

<u>On-Going Projects (Healthy Families/Early Childhood Program)</u> – After an outcome evaluation completed in 1996, the CFC approved successful components for the Healthy Families/Early Childhood Program. Auburn Healthy Start and Kent Healthy Start (Children's Home Society of Washington), Eastside Healthy Start and Sno-Valley Healthy Start (Friends of Youth) are now "on-going projects" using elements of the Healthy Start model. The Funding Policy for Healthy Families/Early Childhood Program will address *new* Healthy Families/Early Childhood projects.

King County Children and Family Commission Programs

Family Support Program

Family Support projects support innovative approaches that protect and sustain families and that provide a nurturing environment for children, youth, and families. Projects are

community-based and build family and neighborhood strengths and skills in ways that enable families to help themselves and others.

Attachment A is a list of thirteen Family Support demonstration projects funded from 1996-1998. Through the 1998 Budget Ordinance, there was an increase in the Marriage License Fee to fund family support programs which provided \$210,000 new funds. The CFC conducted a process to distribute the new funds and is currently completing the contracts for seven new Family Support demonstration projects.

Furthermore, in 1998, the CFC is soliciting applications for Family Support demonstration projects to begin January 1999. Once the Council approves the Funding Policy for the Family Support Program, the policy will apply to the new Family Support projects.

Safe Communities/Youth Partnership Program

Safe Communities/Youth Partnership projects provide positive options for youth through developing community partnerships. The goals of the projects are: improve community safety; improve academic achievement; improve access to services, improve family functioning; and increase the percentage of youth who remain or become free of tobacco, alcohol and other drugs.

Attachment B is a list of six Safe Communities/Youth Partnership demonstration projects funded from 1996-1998. In 1998, the CFC is soliciting applications for Safe Community/Youth Partnership demonstration projects to begin January 1999. Once the Council approves the Funding Policy for the Safe Community/Youth Partnership Program, the policy will apply to the new Safe Community/Youth Partnership projects.

Healthy Families/Early Childhood Program

Healthy Families/Early Childhood projects promote the healthy development of children from birth to five years old. The program uses a Healthy Start model of early childhood intervention proven to reduce child abuse and neglect in the state of Hawaii.

There are three Healthy Families/Early Childhood projects. The Auburn Healthy Start and Kent Healthy Start (Children's Home Society of Washington) and the Eastside Healthy Start and Sno-Valley Healthy Start (Friends of Youth) are "on-going projects." The Southwest King County Early Intervention and Prevention Program (Neighborhood House) is a *new* Healthy Families/Early Childhood project. This project is in the initial development phase.

Attachment C is a list of three Healthy Families/Early Childhood projects -- two on-going projects and one new project. Once the Council approves the Funding Policy for the Healthy Families/Early Childhood Program, the policy will apply to *new* Healthy Families/Early Childhood projects.

The King County Children and Family Commission (CFC) shall fund Healthy Families/Early Childhood projects reflecting adopted County policies for children and family services, and the mission and values of the CFC.

Funding Criteria

1. All healthy families/early childhood projects funded by the CFC shall be consistent with the CFC's overall mission statement, funding priorities, and values as specified below:

Mission Statement

- 3. Projects that are selected for on-going support will continue to be evaluated by the CFC, or designee, on a mutually agreed upon schedule between the evaluator, the project, CFC and/or department. Each project selected to continue will have:
 - explicit outcomes;
 - evaluation plan that includes a periodic evaluation to determine the continued merit of the project based on consumer outcomes and impact on the community;
 - written agreement of collaboration defining each partner's financial and/or inkind contribution signed by the appropriate individuals; and
 - funding from other funders at a percentage to be negotiated at the time of continuation.
- 4. Projects selected for continuation beyond the demonstration phase will be required to reapply for funds every two years through a refunding application process conducted by the CFC or the department in which the project is administered. The application will review at a minimum the following criteria:
 - Collaboration among existing service systems, schools, and other community institutions;
 - Current priority need of the community and if project is addressing that need;
 - Evaluation plan and results of any previous evaluation; and
 - Contributions of other funders.
