1	A MOTION requesting the King County Executive
2	establish a waste reduction and recycling grant program
3	for suburban cities.

6	WHEREAS, King County has adopted waste reduction and recycling goals as part
7	of its waste management system and places many responsibilities on suburban cities
8	participating in the solid waste system, as designated in the 1992 Comprehensive Solid
9	Waste Management Plan, and
10	WHEREAS, King County has provided financial assistance, in the form of grants
11	since 1989, to help the participating suburban cities implement recycling collection, yard
12	waste collection, and waste reduction and recycling support programs, as authorized by
13	motion numbers 7638, 8407, and 9847, respectively, and
14	WHEREAS, Ordinance No. 13678 adopting the 2000 Annual Budget for King
15	County provides \$400,000 in funding for a waste reduction and recycling grant program
16	to assist the participating suburban cities, and
17	WHEREAS, King County is currently developing the 2000 Comprehensive Solid

Waste Management Plan that includes aggressive waste prevention and recycling goals
and involves participating suburban cities as the county's partners in reaching these
goals, and

21 WHEREAS, the 2000 Comprehensive Solid Waste Management Plan is in draft 22 form and will not be adopted until the second quarter of 2001 at the earliest, and 23 WHEREAS, the county, in the interim, would like to continue to support the 24 waste reduction and recycling efforts of participating suburban cities; 25 NOW, THEREFORE, BE IT MOVED by the Council of King County: 26 A. The executive is requested to establish and implement a two-year waste 27 reduction and recycling grant program for the years 2000 and 2001 for suburban cities 28 participating in the county's solid waste system. The grant program shall be 29 implemented according to the provisions in "Attachment A", dated June 20, 2000. 30 Β. Following county adoption of the 2000 Comprehensive Solid Waste

Management Plan, the executive is requested to transmit legislation establishing an on-31

32 going waste reduction and recycling program for 2002 and beyond.

2	2000-2001 Waste Reduction and Recycling Grant Program

4	A. Grant funds shall be made available only to suburban cities operating under King
5	County's Solid Waste Management Plan. The maximum amount of each grant shall be
6	based upon the applicants' per capita share and, if deemed appropriate by the executive,
7	additionally by the applicants' employment based share of available funds.
8	B. Funds in the amount of \$400,000 from the King County Solid Waste Division's 2000
9	adopted budget will be available for distribution as grants to participating suburban
10	cities in 2000. Funds for 2001 shall be subject to council appropriation.
11	C. Any distribution of grant funds under this program shall be in accordance with county
12	policies in effect at the time of such distribution.
13	D. Grant-funded programs and/or activities of participating suburban cities shall address
14	one or more of the following objectives:
15	• Encourage and promote waste reduction.
16	• Continue to implement and improve general recycling programs.
17	• Improve opportunities for the collection of specific commodities, such as paper.
18	• Improve opportunities for the collection and/or composting of organic materials.
19	• Increase the demand for recycled and reused products.
20	• Foster sustainable development through the promotion of sustainable building
21	principals in construction projects.
22	• Manage solid waste generated by public agencies in a manner that demonstrates
23	leadership.
