A MOTION ratifying an original interlocal agreement to 1 2 construct improvements to 244th Avenue Southeast with the city of Enumclaw, and authorizing the county executive 3 4 to amend the agreement. 5 6 7 WHEREAS, improvements to 244th Avenue Southeast would benefit the 8 residents of both King County and the city of Enumclaw by improving traffic and 9 pedestrian safety on this minor arterial, and WHEREAS, the King County Enumclaw Community Plan, the King County 10 11 Transportation Needs Report, and the city of Enumclaw Transportation Improvement 12 Plan have identified the need for this project, and 13 WHEREAS, part of the project to construct improvements to 244th Avenue Southeast is in unincorporated King County and part of the project is in the city of 14 15 Enumclaw, and

16	WHEREAS, it is in the best interest of King County and the city of Enumclas
17	to establish a lead agency to coordinate this project and to provide for the design,
18	construction and financing of the project, and
19	WHEREAS, the King County Council wishes to ratify the original agreemen
20	between King County and the City of Enumclaw to design and construct improvements
21	to 244th Avenue Southeast signed on March 2, 1998, and
22	WHEREAS, the parties desire to amend the original agreement to revise the
23 .	scope of work, reduce the limits of the project and increase the city of Enumclaw's
24	financial contributions, and
25	WHEREAS, the original agreement provides that the agreement may be
26	amended only by an instrument of writing, duly expressed by both parties;
27	NOW, THEREFORE BE IT MOVED by the Council of King County:
28	The original agreement signed by King County and the city of Enumclaw related
29	to improvements to 244th Avenue Southeast is now ratified. Furthermore, the King
30	County executive, on behalf of the citizens of King County, is hereby authorized to
31	execute, substantially in the form attached to this motion, an amended interlocal
32	agreement related to the improvements to 244th Avenue Southeast with the city of

33 Enumclaw.

# AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN KING COUNTY AND THE CITY OF ENUMCLAW FOR THE CONSTRUCTION OF 244<sup>TH</sup> AVENUE SOUTHEAST

This amendment modifies the Interlocal Agreement between King County ("the County") and the City of Enumclaw ("the City"), titled "Interlocal Agreement Between King County and the City of Enumclaw for the Construction of 244<sup>th</sup> Avenue Southeast" and executed on March 2, 1998 ("the Agreement").

### **RECITALS**

- A. Under the Agreement, the County will design, acquire property, if necessary, and construct improvements to 244<sup>th</sup> Avenue Southeast between State Route 410 and Southeast 456<sup>th</sup> Street and the City will pay the County a lump sum of \$200,000 as its contribution to the project.
- B. The parties are desirous of amending the Agreement to reduce the limits of the project, increase the City's contribution and revise the scope of work.
- C. Section 9.G. of the Agreement provides that the Agreement may be amended only by an instrument in writing, duly executed by both parties.

#### **AGREEMENT**

NOW, THEREFORE, the County and the City agree as follows:

- 1. The limits of the project are amended by inserting "Sunrise Elementary School" in place of "State Route 410" and "SR 410" wherever those terms appear throughout the Agreement.
- 2. The Scope of Work is amended by deleting Section 1.A.(4) which reads "Construct a traffic signal at the SR 410 intersection."
- 3. The City's contribution is increased from \$200,000 to \$300,000. Therefore, the Agreement is amended by deleting the amount "\$200,000" wherever it appears in the Agreement and inserting "\$300,000" in its place.
- 4. Except as modified herein, the terms and conditions of the Agreement shall remain in full force and effect.
