15 taxes;


16 NOW, THEREFORE, BE IT MOVED by the King County Council:



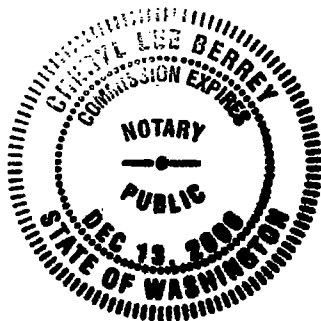
