1           A MOTION authorizing the King County department of  
2           community and human services to accept, on behalf of the  
3           Committee to End Homelessness in King County, a  
4           donation of twenty-six thousand three hundred thirty-six  
5           dollars from Green River Homes, LLC, for the purpose of  
6           funding the work of the Committee to End Homelessness in  
7           King County to create programs that provide housing and  
8           housing-related services for homeless persons.

11           WHEREAS, a significant number of persons are homeless in King County on any  
12           night, and

13           WHEREAS, the King County council has adopted the Ten Year Plan to End  
14           Homelessness, and

15           WHEREAS, pursuant to the Ten Year Plan to End Homelessness, the participants  
16           therein, including King County, have established the Committee to End Homelessness in  
17           King County and its governing bodies, and

18 WHEREAS, the King County council has designated the Committee to End  
19 Homelessness in King County as its Local Homelessness Task Force under Chapter 484  
20 Laws of Washington 2006 (Engrossed Second Substitute House Bill 2163) and is hosting  
21 the Committee to End Homelessness in King County under the auspices of the King  
22 County department of community and human services, and

23 WHEREAS, Green River Homes, LLC, an entity created and managed by the  
24 King County Housing Authority to renovate the Green River Homes, has obtained  
25 financing from the Washington State Housing Finance Commission, and

26 WHEREAS, Green River Homes, LLC, has elected to satisfy its "Placed in  
27 Service" requirement under the Washington State Housing Finance Commission  
28 financing by making a donation to support local housing, and

29 WHEREAS, Green River Homes has elected to make its donation to the  
30 Committee to End Homelessness in King County;

31 NOW, THEREFORE, BE IT MOVED by the Council of King County:

32 The King County council hereby authorizes the department of community and  
33 human services, on behalf of the Committee to End Homelessness in King County, to  
34 accept a donation in the amount of twenty-Six thousand three hundred thirty-six dollars  
35 to be used by the Committee to End Homelessness in King County to further its work in


36 creating programs that provide housing and housing-related services for homeless

Motion 12270 was introduced on 3/13/2006 and passed by the Metropolitan King County Council on 3/27/2006, by the following vote:


