Proposed No. 2007-0645.2 Sponsors Constantine 1 A MOTION authorizing the chair of the council to enter 2 into an amendment of the contract T02739T, oversight of 3 the construction of the Ninth and Jefferson Building at 4 Harborview Medical Center. 5 6 WHEREAS, the metropolitan King County council adopted the 2007 Budget 7 Ordinance, Ordinance 15652, appropriating funds for a pilot project within the King 8 County auditor's office to provide independent and expert oversight of King County's 9 major capital construction projects, and 10 WHEREAS, the King County auditor's office was mandated to manage the pilot 11 capital project oversight function and wishes to retain a consulting firm with expertise in 12 capital projects management and oversight, and 13 WHEREAS, after a competitive procurement process, Jones Lang LaSalle was 14 selected as a winning proposer and the contract T02739T was executed in June 2007, and 15 WHEREAS, the contract's duration is from June to December 15, 2007, and the 16 total contract amount is thirty thousand dollars, and

17	WHEREAS, when a request for proposals for oversight of the Harborview Ninth
18	and Jefferson Building was issued, it was stated in the request for proposals that the
19	contract term would be six months, but might be extended for a longer time, and
20	WHEREAS, the auditor's office is satisfied with the oversight being provided by
21	Jones Lang LaSalle, and wishes to extend the contract duration and increase the
22	compensation accordingly, and
23	WHEREAS, Motion 10651, Section III, as amended, and OR 1-020 requires the
24	council to authorize the council chair to sign any contracts in excess of twenty-five
25	thousand dollars in the legislative branch;
26	NOW, THEREFORE, BE IT MOVED by the Council of King County:
27	The chair of the metropolitan King County council is authorized to amend the
28	existing contract with Jones Lang LaSalle to:
29	A. Extend the contract's duration to June 30, 2008;
30	B. Increase the total contract amount to sixty thousand dollars; and
31	C. Continue the existing scope of the contract to be oversight of the design and

- construction of the Ninth and Jefferson building, with a particular focus on the
- programming, design and budgeting for the tenant improvements.
