1 A MOTION appointing committees to write the voters'
2 pamphlet statements for and against King County Initiative
3 26 for the August 19, 2008, election and the 2008 general
4 election.

6 WHEREAS, K.C.C. chapter 1.10 provides for the publication and distribution of
7 local voters' pamphlets in conformity with the provisions of chapter 29A.32 RCW for
8 even-numbered year primaries when the county has an elective office or measure on the
9 ballot, and

10 WHEREAS, RCW 29A.32.280 provides that for each measure from a unit of
11 local government that is included in a local voters' pamphlet, the legislative authority of
12 that jurisdiction shall formally appoint a committee to prepare arguments advocating
13 voter approval of the measure and a committee to prepare arguments advocating voter
14 rejection of the measure, and

15 WHEREAS, on May 14, 2008, the King County elections division issued a
16 certificate of sufficiency for Initiative 26. The initiative places a proposed ordinance on
17 the ballot at the August 19, 2008, election, which, if passed, would submit a proposed

18 King County Charter amendment to voters at the 2008 general election that would make
19 the offices of King County executive, King County assessor and King County council
20 nonpartisan;

21 NOW, THEREFORE, BE IT MOVED by the Council of King County:

22 Pursuant to RCW 29A.32.280, the following individuals are appointed to serve on the
23 voters' pamphlet committees, each committee to write a statement for or against the
24 adoption of Initiative 26 for the August 19, 2008, election and the 2008 general election:


