**Proposed No.** 2008-0427.1 Sponsors von Reichbauer 1 A MOTION authorizing amendments to restrictive 2 covenants and conditions recorded under file number 3 8507170958, as requested by the Nicholson Place 4 Homeowner's Association. 5 6 WHEREAS, a Declaration of Nicholson Place, Restrictive Covenants and 7 Conditions ("RC&Cs"), was recorded with the King County recorder's office on July 17, 8 1985, under recorder's file number 8507170958, and 9 WHEREAS, Articles 9.1 and 9.3 of the RC&Cs provide that the RC&Cs may be 10 amended upon the written consent of at least seventy-five percent of the owners and "the 11 consent of the King County Council," and WHEREAS, Article VI of the RC&Cs provide that a nonprofit corporation having 12 13 powers and obligations under the RC&Cs would be organized, and the Nicholson Place 14 Homeowner's Association ("Nicholson Place HOA"), a Washington nonprofit 15 corporation, warrants and represents that it is the association subject to the RC&Cs, and 16 WHEREAS, the Nicholson Place HOA warrants and represents that it has 17 collected the written consent of at least seventy-five percent of the owners for an

## AMENDMENT NO 1 TO DECLARATION OF NICHOLSON PLACE, PHASE I RESTRICTIVE COVENANTS AND CONDITIONS

WHEREAS, a certain Declaration of Nicholson Place, Phase I, Restrictive Covenants and Covenants (Declaration) was recorded on July 17, 1985, under Recording Number 8507170958, in the records of King County, State of Washington, and

WHEREAS as provided in Article 9.1 and 9.3 of the Declaration that the Declaration can be amended by an affirmative vote of the owners of not less than seventy-five percent (75%) of the Lots, and the consent of the King County Council, and the Board of Directors for Nicholson Place Homeowners Association has received in excess of seventy-five percent (75%) approval from the members and consent from the King County Council for the following amendment of the Declarations,

NOW THEREFORE, the President and the Secretary of the Nicholson Place Homeowners Association certifies that the Declaration be amended in the following particulars:

1. Article 5.4 shall be deleted and replaced with:

#### Article 5.4 Membership Appointment Removal

The Architectural Control Committee (ACC), herein after referred to as Committee, shall consist of not more than five (5) MEMBERS as the BOARD OF DIRECTORS may from time to time appoint. AT LEAST TWO (2) MEMBERS OF THE ACC SHALL BE A MEMBER OF THE BOARD OF DIRECTORS. The BOARD may remove any member of the Committee from office at any time and may appoint new or additional members at any time. The BOARD shall keep on file at its principal office a list of names and addresses of the members of the Committee. A

member of the Committee shall not be entitled to any compensation for services performed pursuant to these covenants. THE COMMITTEE MAY CONSIDER ALTERNATIVE EXTERIOR ROOF, SIDING AND WINDOW MATERIALS PURSUANT TO THOSE MATERIALS SET FORTH IN ARTICLE 3, SECTION 3.18.

WHEREAS, a certain Declaration of Nicholson Place, Phase I, Restrictive Covenants and Covenants (Declaration) was recorded on July 17, 1985, under Recording Number 8507170958, in the records of King County, State of Washington, and

WHEREAS, the Declaration was previously amended by Amendment No	1 in the records
of King County, State of Washington, on July, 2008, under Recording No	2
and	

WHEREAS as provided in Article 9.1 and 9.3 of the Declaration that the Declaration can be amended by an affirmative vote of the owners of not less than seventy-five percent (75%) of the Lots, and the consent of the King County Council, and the Board of Directors for Nicholson Place Homeowners Association has received in excess of seventy-five percent (75%) approval from the members and consent from the King County Council for the following amendment of the Declarations,

NOW THEREFORE, the President and the Secretary of the Nicholson Place Homeowners Association certifies that the Declaration be amended in the following particulars:

1. Article 9.1 and 9.3 shall be deleted and replaced with:

#### 9.1 Term

These Covenants shall run with the land with respect to any property within NICHOLSON PLACE, PHASE I, for a period of not less than twenty (20) years and shall be binding on all parties and all persons. These covenants can be

amended or revoked with the consent of a minimum of 75% of all lot owners. Such action shall be accomplished by duly recording an instrument which contains an agreement providing for termination and revocation or amendment, and which is signed by the owners of at least seventy-five (75%) percent of the platted lots as previously noted.

#### 9.3 Amendment and Repeal

These covenants or any provision thereof, as from time to time in effect with respect to all or any part of NICHOLSON PLACE, PHASE I, may be amended or repealed by an affirmative vote or the written consent of not less than seventy-five percent (75%) of the owners in accordance with provision 6.2. Any such amendment or repeal shall become effective only upon the recordation of a certificate executed by two officers entitled to act in the name of the Association, setting forth in full the amendment, amendments or repeal so approved and certifying that said amendment, amendments or repeal have been approved in accordance with the provisions herein.
