Proposed No. 2009-0436.1 Sponsors Patterson 1 A MOTION supporting a multicounty work force housing 2 down payment assistance initiative to assist in restoring the 3 economic vitality of western Washington 4 5 WHEREAS, the American Recovery and Reinvestment Act was passed by the 6 United States Congress with the goal of stimulating the economy and providing jobs for 7 Americans, and 8 WHEREAS, one of the principle drivers in the current economic crisis is the 9 decline of the housing industry, resulting in increasing foreclosures, loss of jobs and 10 reductions in public and private revenues, and 11 WHEREAS, this decline has led to thousands of homes being on the market, often 12 at depressed prices, which further depressed the real estate market and increases 13 unemployment, and 14 WHEREAS, an active housing industry is a major creator of jobs and wealth: construction of one hundred single family units has been shown to create one hundred 15 16 jobs, \$18.1 million in local income and \$2.8 million in taxes and fees; and

17	WHEREAS, the Puget Sound region has been concerned for a number of years
18	over the issue of "workforce housing," which refers to the difficulty of working families
19	in this region who have moderate means of affording homes in the communities where
20	they work, and
21	WHEREAS, in the current depressed market, many of these families could afford
22	to purchase homes, having the necessary credit and the ability to make payments, but lack
23	the necessary down payment, and
24	WHEREAS, assisting these families in the purchase of a home would have
25	multiple benefits including increasing the availability of housing to middle income
26	families, reducing the existing over-supply of housing on the market, creating jobs,
27	increasing family incomes and providing local revenues for local, state and federal
28	governments, and
29	WHEREAS, the Puget Sound region seeks to apply principles of equity and social
30	justice through an economic strategy that will create communities of opportunity, where
31	individuals have access to livable wages, affordable housing, quality education, quality
32	health care and safe and vibrant neighborhoods, and
33	WHEREAS, providing first time homebuyers with down payment assistance will
34	promote many of these economic goals, and
35	WHEREAS, King County, Pierce county, Thurston county, Clark county and
36	Snohomish county have worked together with representatives of the non-profit and for-
37	profit housing industry to develop the outline of the Work Force Housing Down Payment

39	WHEREAS, King County, Pierce county, Thurston county, Clark county and
40	Snohomish county intend to request \$50 million in Neighborhood Stabilization Fund
41	dollars for the Work Force Housing Down Payment Assistance Initiative, and
42	WHEREAS, the proposal will be written and submitted to the federal Department
43	of Housing and Urban Development by the state Department of Commerce, who would
44	also administer the program, and
45	WHEREAS, the Work Force Housing Down Payment Assistance Initiative is
46	designed to create a region-wide pool to provide down payment assistance to first time
47	homebuyers according to the rules set forth by the federal Department of Housing and
48	Urban Development, and
49	WHEREAS, targeted down payment assistance under the Work Force Housing
50	Down Payment Assistance Initiative would be in the form of a loan, payable upon the
51	refinancing or sale of the home, and
52	WHEREAS, targeted down payment assistance is available for six hundred
53	affordable foreclosed properties, for up to twenty percent of their value, and
54	WHEREAS, all funds must be used for those earning one hundred twenty percent
55	or less than the median income, with twenty-five percent of funds allocated for those
56	earning fifty percent or less than the median income, and
57	WHEREAS, these loans, as repaid, would establish a revolving fund to continue
58	assistance into the future which will provide ongoing opportunities, and
59	WHEREAS, this stimulus measure will spur economic growth with job
60	stabilization and new jobs for those involved in real estate transaction, banking industry
61	and housing trades, and
