1 A MOTION adopting the 2013 work program for the law,
2 justice, health and human services committee.

3 WHEREAS, the law, justice, health and human services committee is charged
4 with considering and making policy recommendations relating to:

5 1. Law, safety, criminal justice and emergency management programs including
6 those related to public safety; the sheriff's office; adult detention; juvenile justice and
7 youth services; superior and district courts; judicial administration; prosecuting attorney;
8 public defense; therapeutic courts; emergency medical services; emergency management,
9 including disaster response, emergency preparedness and emergency planning;

10 2. Public health programs, including those related to the protection, promotion
11 and provision functions of the department of public health, including the structure of the
12 public health centers; and

13 3. Human services programs, including mental illness and chemical
14 dependency; homelessness and homeless housing; and civil rights and social justice, and

15 WHEREAS, the committee shall also consider the implementation of appropriate
16 labor agreements, and

17 WHEREAS, in the areas within the committee's purview, the committee shall
18 track state and federal legislative action and develop recommendations on policy
19 direction for the 2014 budget, and

20 WHEREAS, the committee has, therefore, developed a work plan for 2013 to
21 facilitate its review and development of policy options and recommendations on these
22 and other issues, and

23 WHEREAS, the work of the law, justice, health and human services committee
24 centers on two major goals of the King County Strategic Plan:

- 25 1. Supporting safe communities and accessible justice system for all; and
- 26 2. Promoting opportunities for all communities and individuals to realize their
27 full potential, and

28 WHEREAS, in 2013, the committee will review and recommend policies and
29 legislation to the council that further these goals and improve the safety and well-being of
30 our region, and

31 WHEREAS, the committee seeks full council involvement in and support for its
32 work program;


