Metropolitan King County Council Government Accountability and Oversight Committee 2015 Work Program

The Government Accountability and Oversight Committee will consider and make recommendations on:

- Improving the efficiency, cost effectiveness, and performance of all branches of County government;
- Enhancing oversight, accountability, and transparency in County government; and
- Increasing general government oversight.

During 2015, the Committee will focus on the following issues:

 Technology Oversight and Monitoring. Review activities, reports, policy proposals, and plans for King County's use of technology to improve delivery of public services.

Key Work Program Items:

- Review and make recommendations to the full Council on Review annual update to the County's Strategic Technology Plan
- Review Benefit Achievement Plans for proposed and ongoing IT projects
- Track and report on any related budget, provisos and responses, including
 - o the proviso response related to the Constituent Relationship Management Expansion Project (Ordinance 17695, Section 63, as amended by Ordinance 17781, Section 7, Proviso P3), and
 - o the proviso response related to business transformation (Ordinance 17941 Section 24, Proviso P2)
- 2. **Human Resources Oversight.** Review and make recommendations to the full Council on issues related to King County employees and human resources issues.

Key Work Program Items:

- Review proposed collective bargaining agreements with labor units that are within the committee's jurisdiction
- Receive briefings and review legislation on human resources policy and initiatives, such as leave policies, recruitment, worker safety, voluntary separation, and training
- Review annual reports on apprenticeship and contracting opportunities
- Track and report on any related budget, provisos and responses

3. King County Auditor's Office. Review the work of the King County Auditor as outlined in Motion 14034.

Key Work Program Items:

- Receive briefings on a range of Auditor's Office work items and consider legislative action based on presented findings
- Receive updates on the County's Capital Project Oversight Program
- Track and report on any related budget, provisos and responses, including
 - o A financial review of the King County Enhanced 911 program, and
 - o A technical audit of King County's implementation of Next Generation 911
- **4. Elections Oversight.** Review and make recommendations to the full Council on Elections operations.

Key Work Program Items:

- Consider appointments to Citizens' Elections Oversight Committee
- Review and make recommendations to Council on the 2015 revision of voting precincts (Ordinance 2015-0127)
- Review Citizens' Elections Oversight Committee 2014 Annual Report with briefing from CEOC Chair
- Review and discuss goals, accomplishments and proposed innovations with Elections Director
- Track and report on any related budget, provisos and responses, including
 - o the proviso response related to a five Year Strategic Technology Plan for the department of Elections (Ordinance 17941, Section 34); and,
 - o as appropriate, coordination with Committee of the Whole on the proviso response regarding the department's plan to engage limited English proficiency populations (Ordinance 17695, Section 33)
- **5.** Taxi, Car Sharing and For-Hire Oversight. Review and make recommendations to the full Council on taxicab, ride sharing and for-hire services.

- Briefing on the state legislature's actions related to the for-hire industry
- **6. King County Airport.** Review and make recommendations to the full Council on operations and future planning for the King County Airport. Hold a special meeting and tour at the Airport.
