1           A MOTION confirming Henry Sladek, councilmember,  
2           city of Skykomish, as an alternate member of the King  
3           County Flood Control Zone District advisory committee,  
4           representing the Sound Cities Association.

5           WHEREAS, in 2007, the council adopted Ordinance 15728 to form a countywide  
6 flood control zone district to address flood protection needs, and

7           WHEREAS, Ordinance 15728 also created a fifteen-person advisory committee  
8 for the district in accordance with RCW 86.15.070, and

9           WHEREAS, Ordinance 15728 provides for four nominees from the Sound Cities  
10 Association for a two-year seat to the advisory committee, subject to confirmation by the  
11 council, and

12           WHEREAS, Ordinance 15728 directs the advisory committee to review and  
13 recommend an annual work program and budget for the district, including capital  
14 improvement program projects and funding levels and to submit recommendations to the  
15 clerk of the King County council by August 31 of each year;

16           NOW, THEREFORE, BE IT MOVED by the Council of King County:

17           The Sound Cities Association's nomination of Henry Sladek, councilmember, city  
18 of Skykomish, as an alternate member on the King County Flood Control Zone District

19 advisory committee for a two-year term, to expire on December 31, 2017, is hereby
