1 A MOTION authorizing the director of the office of law
2 enforcement oversight to enter into a contract for public
3 engagement and participation services with PRR, Inc.

4 WHEREAS, the council was mandated under Section 265 of the King County
5 Charter to establish by ordinance the office of law enforcement oversight as part of the
6 legislative branch, and

7 WHEREAS, in October 2006, the executive signed Ordinance 15611, which
8 codified the office of law enforcement oversight under K.C.C. chapter 2.75, and

9 WHEREAS, in order to instill confidence and public trust in the fairness and
10 integrity of the police accountability system, the sheriff's office and its employees, the
11 office of law enforcement oversight has the authority to conduct community outreach and
12 engagement activities, and

13 WHEREAS, the office of law enforcement oversight is undertaking a strategic
14 communications and public affairs planning and implementation effort, known as the
15 integrated public affairs program, that will invite the community to help create the office
16 of law enforcement oversight's public affairs, community engagement and public
17 participation program, and

18 WHEREAS, the integrated public affairs program will support and promote the
19 office of law enforcement oversight's strategic goals, mission and vision, as well as

20 influence the functions of the office of law enforcement oversight under K.C.C. 2.75.040,
21 and

22 WHEREAS, the office of law enforcement oversight engaged in a competitive
23 request for proposals procurement process under RFP number 1137-20-VLN for
24 consultant services related to public engagement and participation to support the
25 program, and

26 WHEREAS, PRR, Inc., was selected as the most responsive and responsible
27 proposer, based on the selection criteria, and

28 WHEREAS, the office of law enforcement oversight desires to enter into a
29 contract for public engagement and participation services with PRR, Inc., in the amount
30 of \$140,000, and

31 WHEREAS, under OR 1-020.C, in the council's organization motion compilation,
32 the council must approve execution of any consultant contract with the legislative branch
33 that is in excess of \$50,000 in value;
