8                   WHEREAS, RCW 42.12.070 provides that, in case of a vacancy, remaining  
9 members of the local governing body shall appoint a qualified person to fill the vacancy  
10 within ninety days of the occurrence of the vacancy, and

11                  WHEREAS, RCW 42.12.070 provides further that, if the local governing body  
12 does not fill the vacancy within ninety days, its authority to fill the vacancy ceases, and  
13 the county legislative authority shall appoint a qualified person to fill the vacancy, and

14                  WHEREAS, the Bothell city council has not filled the city council vacancy within  
15 the specified ninety-day period;

16                  NOW, THEREFORE, BE IT MOVED by the Council of King County:

1. Why are you interested in serving as a Bothell City Councilmember?	I moved to Bothell in 1993 at age 5. I didn't have a lot of choice in the decision, but I know now that my parents chose Bothell as an affordable place with good schools. This decision shaped my family's entire future for the better. If my working-class parents were buying today, they could not afford to live here. In my adult life, Bothell was out of reach for my family; the first home I purchased was in unincorporated Snohomish County simply because it's where I could buy.

We need to become more well-rounded again, with working-class families like the one I grew up in still able to afford to live here. Bothell is hard to buy into and hard to stay in. I am lucky enough to have friends and family in all stages of life who share their struggles and successes, and luckier still to hear about these challenges through community engagement as well. Council has the capacity to address the systemic causes of the affordability crisis, and I'm interested in working with my neighbors toward solutions that benefit us all. We can turn the tide, but we need to work together and ensure our neighbors understand why and how every measure we might take are good choices for our city.

2. How would the Council and community benefit from your strength(s) or lived experiences?

My life, since age 5, has been in Bothell. I not only sleep here at night but I LIVE here—I work from my Bothell home and have my local coffee and dinner haunts that know my family by name. My son's school, our church, our veterinarian, our tax guy—all in Bothell. I am a bit of an extrovert and talk to so many of our neighbors here, and I would love to be able to boost and share their stories of what makes Bothell great and how we can make it better. I see opportunities for the perspectives I've gained living in the northwesternmost part of our city to complement the voices we have on council today.

In my professional life, I am a Technical Account Manager at a software company. My job is to know best practices, be able to explain them and why they exist, and help my clients adapt them to their use cases. In short, I am a professional communicator, and have found this skill set very useful in community building. Being able to communicate the 'why' and 'how' of each change in our city is key to our community understanding and embracing the actions we take.

3. What are the three highest priorities and/or issues you believe the City needs to address? How would you propose to address these issues?

- I would love to help keep Bothell solvent and vibrant. Our community often voices their desire for more robust/accessible parks and facilities, preservation of natural areas, all-ages events, and things that bring us together. Our budget directly impacts how we can address these needs. It's important to me that we apply what works in other cities so we can serve our community at a higher level.

- Public safety, encompassing both what we typically think of (Fire/EMS, Police, RADAR), along with what not everyone sees in their own Bothell existence (safety for pedestrians, cyclists, those using mobility aids, and those who do not drive).

- Many neighbors are not aware of (or not comfortable using) opportunities to have their voices heard. Often, we allow special interests to drum up concern with incomplete narratives, further dividing our community. We must shed light on how our city moves (at a thoughtful pace; changes should not be a surprise!). We need to hear personal stories that we just can't glean from

abstract data. Personal experiences and data working together (along with creative thinking from staff/council) will allow us to live up to our full potential as a city.

4. Explain your current and past community involvement and/or service on school, city, non-profit, public boards, commissions, committees, or task forces and how this has contributed to the Bothell community. Address its relevance to the position of a Bothell City Councilmember.

I currently serve on the Planning Commission. I have greatly enjoyed my time on the Commission and have learned so much about the research and thought that goes into every decision we make. Previously, I was a founding and leading member of Bothellites for People-Oriented Places (BoPOP) from 2018-2020, but left upon my appointment to the Commission.

In 2019, I spent part of my summer in a CERT class with our awesome Fire Department. I was able to join the our Police Department for their inaugural Community Academy in Fall 2021, and have been able to return a few times for engagement opportunities this year, such as a ride along in May. I greatly appreciated the opportunity to learn more about BPD and their plans for the future - RADAR expansion remains one of my most anticipated changes in our city.

Informally, I volunteer as I am able. I have been able to work with Habitat for Humanity, Mary's Place, Seattle Children's, my church home at Bothell United Methodist, and virtually through online community engagement. (I would like to clarify that, if appointed, I would step down from administering the handful of local Facebook groups I help with.)

5. What do you wish to accomplish during this appointed term as a Bothell City Councilmember?

I want to see our city through pandemic recovery, work with the council and staff to find ways to ease the unsustainably high cost of housing while protecting the environment around us, and see us really expand our community's relationships and recreation opportunities. I value good working relationships amongst the council with compromise in mind and the ethos of always putting community first. Bothell has been a special place for me to grow up and raise my family and I look forward to ensuring that it can be that special place for everyone.

6. What is your vision for our City and community?

My vision is to see a community that comes together for all of us—supporting each other, celebrating together, and working together to ease the burden when one of us is struggling. It means reshaping some of our conversations around how to help each other when we see something we don't like, and it means taking extra care to understand those who live differently than we do. I love that we have been celebrating a range of holidays and observances in Bothell—what a way to welcome people who do not worship or live like I do! Bothell is stronger together, and the more we can learn and celebrate each other, the better and more loving community we will be.

The key to harmony is pausing to understand where your neighbor is coming from and how to land somewhere together.



All too often we see people shy away from what they don't know or disagree with; I'd like to continue to set the tone in building a community that supports each other even when we don't take the same path in life.

7. Is there anything else that you wish to add that would help us get to know you a little better?

I am first and foremost a mom to my six year old son, James. This summer we've been hitting our local trails on foot and on bike, visiting our parks, and enjoying being able to once again gather with our neighbors at the Maker's Markets, Fourth of July festivities, and summer events. It's most important to me that Bothell continues to be a place where he can be safe and loved in the community, and where we can extend that feeling to anyone who chooses to be here.

1. Why are you interested in serving as a Bothell City Councilmember?	I'm deeply committed to the Bothell community and have been involved in the city in various ways the past seven years. After serving on the Landmarks Board, and now Planning Commission, and thanks to my work as an architect and developer, I have a deep understanding of the growing pains Bothell is experiencing around housing, building community, economic development, recreation, budget constraints, and more. I have attended countless city council meetings and can

credibly say I've been one of the most involved and visible residents in city and civic life. Bothell is growing and changing rapidly and desperately needs the vision and innovative thinking a professional placemaker such as myself can bring. I can no longer sit on the sidelines when the city needs creative, bold ideas I can provide.

2. How would the Council and community benefit from your strength(s) or lived experiences?

As a professional architect, small developer, builder, planner, and urbanist who has traveled widely, I bring a broad perspective on how a city can evolve, improve, and become a stronger place for residents and visitors. As a downtown Bothell resident since 2015 I've been enmeshed in city policy making activities weekly and deeply understand the city's situation better than most residents. I would already be "up to speed" on most issues the council deals with. I also founded BoPOP, a local advocacy group that is involved with building a better Bothell. In my work, sticking to a budget is paramount, and my skills at long range budgeting would be helpful to the city council. Every city council should have a member who is involved in \*building\* cities, and that is what I do. I live in Bothell in large part to build a better city and community. All who know me would agree it's a passion of mine.

3. What are the three highest priorities and/or issues you believe the City needs to address? How would you propose to address these issues?

1) The city of Bothell desperately needs a lot more housing for people who want to call Bothell home. We can do this through massaging our land use code to allow for more "gentle density" like infill missing middle housing, encouraging homes where infrastructure already exists, and clustering communities of homes near services, transit, schools, and parks. 2) Bothell also needs to leverage its downtown and Canyon Park to become the economic engines they could be to pay our bills. I helped bring Urban3 to the attention of city leaders, and their work will help Bothell understand how to generate more income to pay our debts. 3) Bothell should be a great place for everyone, regardless of race, income, religion, or sexual orientation. The city is wise to prioritize equity, anti-racism, and inclusion in every part of city business, and this work needs to permeate every city department and policy as soon as possible, whether its zoning, hiring, pay, transportation or any area, no matter how small.

4. Explain your current and past community involvement and/or service on school, city, non-profit, public boards, commissions, committees, or task forces and how this has contributed to the Bothell community. Address its relevance

In Bothell I served three years on the Landmarks Preservation Board (2018-2021) including Chair. I then was appointed to the Planning Commission where I'm currently serving through 2025. While living in Kenmore, prior to Bothell, I served on Arrowhead elementary PTA for 7 years, including a year as president. When moving back to Bothell in 2015 after 11 years in Kenmore, and growing up in Woodinville, I endeavored to involve myself in city life as much as possible. I'm a licensed architect and live downtown, where I developed and built a mixed-use fourplex on my property near the library. Since summer 2020 I have served as a board member for Habitat for Humanity Snohomish County

to the position of a Bothell City Councilmember.

and chair their Real Estate Committee. My extensive experience on boards, commissions, and working as a built environment professional have given me a robust and complete background well suited to serving on city council. I can step in and be effective on day one.

5. What do you wish to accomplish during this appointed term as a Bothell City Councilmember?

I'd like to see Bothell improve its fiscal health through revitalizing and continuing to build out downtown and Canyon Park as hubs of community and business activity. As a byproduct, we will enjoy a more thriving city that also attracts visitors to our city. This will require ongoing work with the planning commission and our community development department. I'd like to work to improve transit and safe human-powered mobility throughout the city for the 25% of residents who cannot drive a car. True equity means free and safe movement for that group of residents as well. This also means less traffic for our residents who still need to drive. Finally, I'd like to work on improving our parks and recreation offerings and considering a splash pad, pump track, skate park, and similar amenities other cities enjoy and which create rich community life. Residents rank these as high priorities, along with housing costs and traffic woes.

6. What is your vision for our City and community?

Bothell is on the cusp of greatness. I fervently believe that Bothell will be a destination city that attracts visitors, the best businesses, and enjoys an enviable community life. We do this through robustly and boldly creating an attractive, bustling, prosperous downtown and Canyon park that is focused on people, residents first, and providing everything they need to thrive. By creating a top quality living experience for our residents it will attract visitors who want to experience Bothell as well, and then we've got the "flywheel" going and good things produce more good things. Bothell has been doing a lot of things right, and there is a good base on which to build. By focusing on being a strong and healthy city, we can then spend more on parks, human services, public safety, and other programs. The best Bothell lies ahead, and we are on track to build it.

7. Is there anything else that you wish to add that would help us get to know you a little better?

I'm a father to Lana (18 - recent IHS grad!) and Leah (12) who have grown up attending Northshore schools. My wife, Julie Westerbeck, has been a teacher and librarian at Inglemoor since 1994. I grew up in Woodinville and attended Northshore schools as well, graduating from Inglemoor in 1988. My immediate family is all in the northwest, and my 76 y.o. Mom lives in an apartment in my recently built fourplex, where I reside with my family on the top floor as well. We love living downtown and walking to everything it has to offer. I'm a busy architect and have worked all over the region. I know the northwest on a deep and visceral level and have spent my life hiking, cycling, camping, and climbing all over the state. Prior to architecture I was a bicycle mechanic for 8 years. Following my UWB degree I worked for the City of Seattle for 3 years. I graduated from the UW Bothell in

1999, and earned a Master of Architecture from UW Seattle in 2004. I have traveled widely in the U.S., Europe, and Canada, and spent time in Mexico, the Caribbean, and Brazil. My deep life experience has taught countless lessons that would inform my time on the city council.



## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

### **Consequences of changing your mind**

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures.
