3 WHEREAS, the King County council and the King County executive work
4 together through their respective government relations staff and desire to bring their
5 positions on federal issues to the attention of the 118th Congress, and

6 WHEREAS, King County desires to work cooperatively with other local
7 governments and other organizations to achieve its 2023 federal legislative goals, and

8 WHEREAS, King County is dependent on a strong fiscal partnership with the
9 federal government for addressing local needs in transit, transportation, infrastructure,
10 public health, behavioral health, veterans and human services, affordable housing,
11 poverty, homelessness, public safety, flood control, and many other areas, and

12 WHEREAS, King County is dependent on a strong federal response to combat
13 climate change and ecological collapse, protect constitutional and human rights, preserve
14 democracy and the rule of law, and provide for national safety, defense and security, and

15 WHEREAS, the King County council and the King County executive will
16 continue to review congressional developments for possible revisions of King County's
17 2023 federal legislative goals;



Investing in a Green Economy & Workforce

King County is setting the bar nationally in confronting climate change. We have comprehensive, integrated strategies in place throughout county government that will: quickly and dramatically decrease greenhouse gas emissions countywide; elevate the voices and expertise of frontline communities, especially those disproportionately impacted by climate change; and prepare our region for climate impacts. With federal support, King County is poised to:

- Electrify the transportation system, including buses and supporting infrastructure. King County is poised to lead the nation in creating a fully electric bus fleet by 2035 to meet emission reduction goals.
- Deliver transit projects that keep the region moving, connect people to jobs, and prioritize clean transit and mobility services to meet rising demand in ethnically diverse and working-class areas that have been historically marginalized.
- Encourage and promote the creation of green jobs by investing in green jobs skill development and employment pipelines, including a green transportation workforce skilled in servicing low-carbon transportation technologies.
- Maximize transportation funding opportunities through FTA Capital Investment Grants, competitive grants, and formula grant programs, and encourage timely distribution of funds awarded under the programs. These federal grant programs are a critical source of funding for local and regional multi-modal projects throughout the Puget Sound area, including RapidRide bus rapid transit, and the Eastside Rail Corridor.
- Coordinate and implement safety improvements countywide to achieve Vision Zero goals and increase access to clean, multi-modal transportation options.
- Install an EV charging network through the region's most heavily used corridors and in historically disadvantaged communities.
- Support policies and programs to reduce greenhouse gas emissions, support sustainable aviation fuel, and improve fuel economy and Energy Star Appliance standards that conserve energy and fuel, save money, and build our clean energy economy.

Building a Sustainable and Resilient Future

- Invest in bridge safety and resiliency by bringing county bridges into compliance with federal standards and supporting our partners to complete critical repairs to bridges integral to the regional transportation network.
- Invest in reliable, climate-resilient transportation infrastructure to improve user safety and connect communities and economic sectors and to meet regional growth, including key interstate and highway interchange projects in the Federal Way Triangle.
- Reduce greenhouse gases by building a public transportation system that is fast, frequent, and reliable and that provides innovative mobility options that encourage more people to get out of their vehicles.
- Restore fish habitat and improve the regional watershed by replacing and repairing roads and culverts.
- Improve water quality by providing federal funding for green stormwater infrastructure and combined sewer overflow control to reduce the impacts of stormwater on our rivers, lakes, and Puget Sound.
- Protect communities and wildlife by enacting source controls on 'forever chemicals': persistent and bioaccumulative contaminants that harm our health and pollute the environment.

- Enhance climate resilience by planning for sea level rise; protecting critical regulations like NEPA and the Clean Water Act; and restoring healthy forests and shorelines.
- Advance funding and action of prioritized projects to improve failing Army Corps of Engineers infrastructure, including the 100-year-old Ballard Locks and the Howard Hanson and Buckley Diversion Dams.
- Invest in flood protection, multi-benefit floodplain management, and modernize the National Flood Insurance Program to reduce risks to industry, manufacturing, farmlands, small businesses and working families.
- Support emergency preparedness, response, and recovery planning and capital to prepare for climate impacts and natural disasters, such as wildfire smoke, extreme weather, and earthquakes.
- Partner with King County to upgrade our wastewater treatment facilities, which are necessary to meet federal clean water and environmental regulations.
- Support Southern Resident Orca recovery through investments in Puget Sound ecosystem restoration and salmon population enhancement efforts like Pacific Salmon Recovery Fund.

Bolster Public and Behavioral Health Crisis Response

King County is on the front lines working to keep Washingtonians healthy, housed, and safe. The COVID-19 pandemic exacerbated health inequities facing our Black, Indigenous, and other Communities of Color, and highlighted the need to respond to the crises of racism, mental and behavioral health, and homelessness. King County will continue to work with our local and national partners to protect and promote population and behavioral health and address the root causes of our community and healthcare inequities.

- Support efforts to strengthen national public health infrastructure and provide reliable, sustainable public health funding for local public health agencies to improve local ability to respond to public health emergencies.
- Protect funding for community preparation and response to emergency public health crises, including continued public health response to the COVID-19 pandemic and other disease outbreaks.
- Ensure access to quality, affordable health care for all King County residents, extend funding for community health centers, reduce out-of-pocket health care costs, and increase Medicare reimbursement rates.
- Protect access to a full range of reproductive health care and family planning services, without barriers and unnecessary restrictions.
- Maintain funding for community and health equity programs and grants.
- Address health disparities and ensure overall population health through full funding of the Prevention and Public Health Fund, increasing cancer research funds with the goal of ending cancer, and continue working to end HIV.
- Bolster access to behavioral health and substance use disorder treatment and opioid overdose prevention services and enhance resources for community-based responses to behavioral health crises, including resources and training for first responders.
- Update the IMD exclusion to allow Medicaid to cover short term stays in psychiatric hospitals to help strengthen the overall behavioral health system and provide Medicaid recipients with more treatment options.

- Build on progress made toward addressing the opioid crisis by implementing and fully funding the Comprehensive Addiction and Recovery Act and the SUPPORT for Patients and Communities Act, and by increasing access to naloxone and reducing purchase costs for local governments who buy the drug and distribute it to first responders, social service organizations, medical providers, and others to help save lives by preventing overdose deaths.
- Support and sustain the healthcare and behavioral health workforce, including a 7 percent increase in Medicaid behavioral health rate across all service types.
- Increase veterans' programs, especially those targeting suicide prevention and homelessness.

Invest in Shelter, Housing, Workforce and other Community Needs

- Help families, youth, and veterans avoid homelessness by providing resources for rental assistance, permanent supportive housing, rapid rehousing, and reemployment services. Provide local governments with resources to provide adequate emergency services for those experiencing chronic homelessness.
- Provide local governments flexibility and planning resources to diversify housing stock, and implement programs to build and preserve affordable housing
- Help King County preserve and increase long term residential behavioral health care capacity, including assisted living facilities, transitional homes, and supportive housing units.
- Increase and improve federal programs that help build or preserve affordable housing, including CDBG, Homeless Assistance Grants, Low Income Housing Tax Credits, HOME Program grants, and programs to leverage private-sector investments in affordable housing and preservation.
- Support programs that fund energy efficiency upgrades and broadband access to affordable housing.
- Provide local governments funding to invest in workforce development and apprenticeship programs to help residents learn new skills as a path to economic recovery.
- Increase resources to help close the digital divide by making quality broadband accessible and affordable to all residents.
- Pass comprehensive immigration reform legislation that also provides a path to permanent residence for DACA recipients.

Dismantle Systemic Racism and Injustice and Enhance Public Safety

- Develop and implement initiatives that improve gender equity, prevent sexual assault and harassment, reduce juvenile detention and disproportionality in the criminal legal system, combat human trafficking, and guarantee protection for all people including those in the LGBTQ community.
- Support training, equipment and recruitment and retention programs for law enforcement that help to ensure public safety in King County is conducted in a way that reflects our core values of leadership, integrity, service, accountability, and teamwork.
- Support policies that increase law enforcement officer accountability, prevent and remedy racial profiling and officer misconduct, provide resources to build relationships and trust with underrepresented communities, and enhance transparency and data collection work.
- Enact legislation allowing the cannabis industry to access banking services.

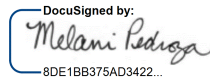

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

How to contact King County-Department of 02:

You may contact us to let us know of your changes as to how we may contact you electronically, to request paper copies of certain information from us, and to withdraw your prior consent to receive notices and disclosures electronically as follows:

We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

To request paper copies from King County-Department of 02

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with King County-Department of 02

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

Required hardware and software
