2 pamphlet statements for the August 5, 2025, special
3 election regarding Ordinance XXXXX (Proposed
4 Ordinance 2025-0130) providing for the submission to the
5 qualified electors of King County of a proposition
6 authorizing a property tax levy in excess of the levy
7 limitation contained in chapter 84.55 RCW, for a
8 consecutive six-year period, at a first-year rate of not more
9 than \$0.2329 per one thousand dollars of assessed valuation
10 for collection beginning in 2026, and limiting annual levy
11 increases in years two through six to the greater of the most
12 recent published King County office of economic and
13 financial analysis King County plus population index or the
14 limitation contained in chapter 84.55 RCW for the purpose
15 of maintaining and operating King County's open space
16 system; improving parks, recreation, access, and mobility
17 in King County by acquiring lands and continuing to

31 WHEREAS, K.C.C. chapter 1.10 provides for the publication and distribution of
 32 local voters' pamphlets in conformity with chapter 29A.32 RCW for elections held in
 33 King County, and

34 WHEREAS, RCW 29A.32.280 provides for each measure from a jurisdiction that
 35 is included in a local voters' pamphlet, the legislative authority of that jurisdiction shall
 36 formally appoint a committee to prepare arguments advocating voter approval of the
 37 measure and a committee to prepare arguments advocating voter rejection of the measure,
 38 and

39 WHEREAS, Ordinance XXXXX (Proposed Ordinance 2025-0130) provides for
 40 submission to the voters at the August 5, 2025, special election, a proposed property tax
 41 levy in excess of the levy limitation contained in chapter 84.55 RCW, for a consecutive
 42 six-year period, at a first year rate of \$0.2329 per one thousand dollars of assessed
 43 valuation for collection beginning in 2026, with the 2026 levy amount being the base for

44 calculating increases in years two through six, and limiting annual levy increases in years
45 two through six to the greater of the most recent published King County office of
46 economic and financial analysis King County plus population index or the limitation
47 contained in chapter 84.55 RCW, and

48 WHEREAS, Ordinance XXXXX (Proposed Ordinance 2025-0130) specifies that
49 the levy proceeds shall be used for the purpose of maintaining and operating King
50 County's open space system; improving parks, recreation, access, and mobility in King
51 County by acquiring lands and continuing to develop and support parks, recreation
52 facilities, and regional trails; improving parks and trails in and acquiring lands by
53 metropolitan parks districts, towns and cities in King County; funding environmental
54 education, maintenance and conservation programs at the Woodland Park Zoo; funding
55 environmental education, maintenance and conservation programs at the Seattle
56 Aquarium; funding development, maintenance, and programming for Seattle's Waterfront
57 park; funding environmental and climate stewardship and education at Pacific Science
58 Center; funding a capital project at Memorial Stadium; and funding capital improvements
59 at public pools, for all King County residents;

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

How to contact King County-Department of 02:

You may contact us to let us know of your changes as to how we may contact you electronically, to request paper copies of certain information from us, and to withdraw your prior consent to receive notices and disclosures electronically as follows:

To let us know of a change in your email address where we should send notices and disclosures electronically to you, you must send an email message to us at cipriano.dacanay@kingcounty.gov and in the body of such request you must state: your previous email address, your new email address. We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

To request paper copies from King County-Department of 02

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with King County-Department of 02

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

Required hardware and software

Acknowledging your access and consent to receive and sign documents electronically
