#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ## **Getting paper copies**

#### To withdraw your consent with King County-Department of 02
