3 AN ORDINANCE granting an Unclassified Use Permit as
4 provided for in King County Zoning Resolution No.
5 25789, as amended, at the request of P. J. ANDERSON,
6 INC., Department of Planning File No. 122-70-P.

7 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

8 SECTION 1. P. J. Anderson, Inc., petitioned on August 20, 1970,
9 for an Unclassified Use Permit for the removal of natural materials de-
10 scribed in Section 3 below, and this application was assigned Department
11 of Planning No. 122-70-P.

12 SECTION 2. The report and recommendation of the Department of
13 Planning was transmitted to the Zoning and Subdivision Examiner on
14 September 29, 1970, and hearing was held by the Examiner on this matter
15 on October 6, 1970. The attached report of the Examiner was filed with
16 the Clerk of the King County Council on October 21, 1970.

17 SECTION 3. The legal description of the subject property is
18 hereby attached as Appendix A and is hereby made a part of this ordinance.
19 The above-described property is shown on the attached map which is desig-
20 nated Appendix B and is hereby made a part of this ordinance. The Unclas-
21 sified Use Permit topography plan is designated as Appendix C and is here-
22 by made a part of this ordinance.

23 SECTION 4. The King County Council does hereby grant an Unclas-
24 sified Use Permit for the removal of natural materials described and shown
25 in Section 3, Appendices A, B and C, above and directs that Area Map No.
26 E 3-26-5 be modified to so designate.

27 SECTION 5. This permit is granted subject to the conditions
28 adopted by King County Council Motion No. 346, and these conditions are
29 incorporated herein as though they were fully set forth herein.
