ORDINANCE NO. 00652

1 AN ORDINANCE granting supplemental appro-
2 priations to the Department of Public Safety
3 (amending Ordinance No. 239) for the oper-
4 ation of the Corrections Development Project
5 and declaring an emergency therefor.

6 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

7 Section 1. The additional sums set forth in Section
8 2 herein are hereby appropriated out of grant funds provided by
9 the U. S. Department of Justice through the Law and Justice
10 Planning Office, Planning and Community Affairs Agency, State of
11 Washington.

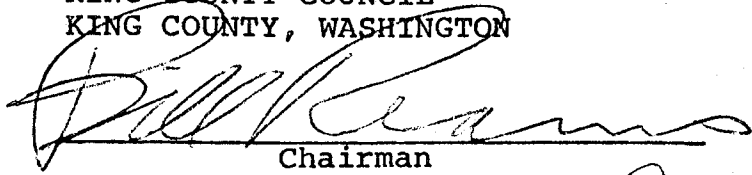
12 Section 2. The following pages, attached hereto and

24 emergency exists and that this ordinance is necessary for the
25 immediate preservation of the public peace, health and safety

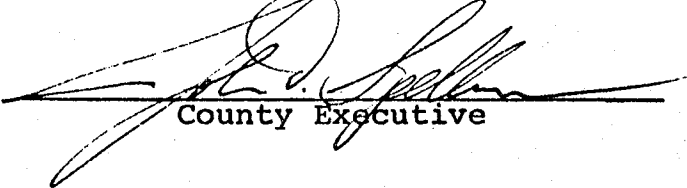
