

ORDINANCE
NO. 985

1 AN ORDINANCE acknowledging unanticipated revenue
2 to the 1971 King County budget and appropriating
3 said revenue to the 1971 Current Expense Fund
4 and amending Ordinance No. 639.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 Section 1: The County Council acknowledges that unantici-
7 pated revenue will be received through the Washington State Plan-
8 ning and Community Affairs Agency, Law and Justice Planning
9 Office for the following grant contracts.

20 Section 2: A supplemental appropriation in the amount of
21 \$20,140.00, as specified in Sections 1 a and 1 b above to the
22 Prosecuting Attorney's Office, is hereby approved and adopted,
23 provided, that said appropriation be utilized for personnel
24 salaries and other allowable expenses as provided in the agree-
25 ments between King County and the Washington State Planning and
26 Community Affairs Agency, Law and Justice Planning Office.
(Grant Award Contract Nos. 493 and 500.)

27 Section 3: A supplemental appropriation in the amount of
28 \$80,228.20, as specified in Sections 1 c, 1 d and 1 e above, to
29 "Special Programs - Work Contracts - Contributions" is hereby
30 approved and adopted provided, that said appropriation be
31 utilized for the reimbursement of allowable expenses as provided
32 in Grant Contract Nos, 369, 392 and 483.
