

ORDINANCE NO. 1037

1 AN ORDINANCE establishing the date for an election on
2 the question of annexation and assumption of indebted-
3 ness to the City of Bellevue of unincorporated terri-
4 tory contiguous thereto.

4 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

5 SECTION 1: The City of Bellevue by Resolution No. 1805 has
6 determined that the best interests and general welfare of the City
7 of Bellevue would be served by the annexation of certain unin-
8 corporated territory contiguous thereto as hereinafter described.

9 SECTION 2: On the 2nd day of April, 1971, there was filed
10 with the City Clerk of Bellevue a timely and sufficient referendum
11 petition calling for submission of the question of annexation and
12 the question of assumption of indebtedness to the qualified voters
13 within said territory.

14 SECTION 3: Said Resolution does satisfy the provisions of
15 R.C.W. 35A.14.299, R.C.W. 35A.14.060 and R.C.W. 35A.14.070 and
16 requests the calling of an election to be held among the qualified
17 voters therein upon the questions of annexation and assumption of
18 indebtedness.

19 SECTION 4: The King County Boundary Review Board by its
20 decision dated August 25, 1971, approved the proposal as submitted
21 all in accordance with R.C.W. 36.93.100; and, further, the time to
22 appeal from such decision has expired.

23 SECTION 5: A special election shall be held on the 4th day
24 of January, 1972, within the territory of the proposed
25 annexation as hereinafter described for the purpose of submitting
26 to the qualified electors within the said territory the proposition
27 of annexation and assumption of indebtedness of the said territory
28 to the City of Bellevue.

29 SECTION 6: The boundaries of the territory proposed for
30 annexation are hereby described as follows:

1 SECTION 7: Notice of election shall be published as required
2 by law.

"EXHIBIT A"

Being the unincorporated area lying generally northeast of Northrup Way, west of 120th N.E., south of approximately N.E. 34th Street, more particularly described as follows:

That portion of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 21, Township 25 North, Range 5 East, W.M., lying northerly of Bellevue City Limits as established by King County Resolution No. 13925 and Bellevue Ordinance No. 418 and south of Bellevue City Limits as established by Ordinance No. 197 and westerly of Bellevue City Limits as established by Ordinance Nos. 125 and 668.

Also, that portion of the east $\frac{1}{2}$ of Section 20, Township 25 North, Range 5 East, W.M., lying northerly of Bellevue City Limits as established by King County Resolution No. 13925 and Bellevue Ordinance No. 418 and southerly of Bellevue City Limits as established by Ordinance Nos. 99 and 844.
