

SUBSTITUTE ORDINANCE
NO. 1072

AN ORDINANCE amending King County Zoning Code Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of

CARL P. PRESENGER

Department of Planning File No. 130-71-P.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. Carl P. Presenger petitioned October 1, 1971 that the property described in Section 3 below be reclassified from RS 15,000 to RS 7200 and this application was assigned Department of Planning No. 130-71-P.

SECTION 2. The report and recommendation of the Department of Planning was transmitted to the Zoning and Subdivision Examiner November 2, 1971 and hearing was held by the Examiner on this matter November 9, 1971. The attached report of the Examiner was filed with the Clerk of the Council November 24, 1971.

SECTION 3. The legal description of the property reclassified is attached as Appendix A and is hereby made a part of this ordinance. The attached map showing the above described property is attached as Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend the King County Zoning Code Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RS 7200 and directs that Area Map No. W 1-26-3 be modified to so designate
