AN ORDINANCE authorizing condemnation of property for the South 216th Street (U.S.99 - Marine View Drive) R/W 1986

WHEREAS, the King County Council, on December 1, 1971, by Ordinance No. 1056, did adopt the 1972 annual budget for King County and did provide therein for the Capitol Improvement Program which adopted the Capitol Program and the Budget including a Transportation Program, and

WHEREAS, the King County Transportation Program provides for a County road system development and improvement program coordinating the kind of road with other elements of the larger transportation system, abutting land uses and business, industry, government and residential processes, and

WHEREAS, the Capitol Improvement Program provides for the acquisition, and construction of South 216th Street (U.S. 99 - Marine View Drive), and

WHEREAS, in order to acquire the property and property rights required to lay out and construct South 216th Street (U.S. 99-Marine View Drive), it is necessary for King County to condemn certain lands and property rights and rights in property for road purposes as hereinafter more particularly set forth, and

WHEREAS, the King County Council finds that the public health, safety, necessity and convenience demand that South 216th Street (U.S. 99-Marine View Drive), be constructed within King County in accordance with the Capitol Improvement Program, and that certain properties, property rights and rights in propert be condemned, appropriated, taken and damaged for the construction of said road, as provided in this Ordinance, and

WHEREAS, the King County Council has deemed it necessary and in the best interests of the citizens of King County that the lands hereinafter described, and other property rights and/or rights in property be condemned, appropriated, taken and damaged for the purpose of constructing South 216th Street (U.S. 99 - Marine View Drive), subject to the making or paying of just compensation to the owners thereof in the manner provided by law.
