Proposed Ordinance 73-327

1 AN ORDINANCE amending King County Zoning Resolution
2 No. 25789, as amended, by amending the Zoning Map thereof
3 reclassifying certain property thereon at the request of
4 Roy A. Bagne, et.ux., Division of Land Use Management File
No. 204-73-P

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

6 SECTION 1. Roy A. Bagne, et.ux. petitioned on May 3, 1973, that
7 the property described in Section 3 below be reclassified from M-P to C-G,
8 and this application was assigned Division of Land Use Management File No.
9 204-73-P.

10 SECTION 2. The report and recommendation of the Division of Land
11 Use Management was transmitted to the Zoning and Subdivision Examiner
12 on June 5, 1973, and hearing was held by the Examiner on the matter June 12,
13 1973. The report of the Examiner was filed with the Clerk of the King County
14 Council on June 27, 1973.

15 SECTION 3. The legal description of the property to be reclassified
16 is attached as Appendix A and is hereby made a part of this ordinance. The
17 above described property is shown on the attached map which is designated
18 Appendix B and is hereby made a part of this ordinance.

19 SECTION 4. The King County Council does hereby amend King County
20 Zoning Code Resolution No. 25789, as amended, by reclassifying that property
21 described and shown in Section 3, Appendices A and B above, to C-G and
