ORDINANCE NO. 1775 Proposed Ordinance 72-112

AN ORDINANCE granting Special Permit as provided for in King County Zoning Code Resolution No. 18801, as amended, at the request of John M Cronkhite Division of Land Use Management File No. 106-72-ZA

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. John M Cronkhite petitioned on February 14, 1972, for a special permit to allow removal of natural materials including a rock crusher as described in Section 3 below, and this application was assigned Division of Land Use Management File No. 106-72-ZA.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner March 28, 1972, and hearing was held by the Fxaminer on the matter April 4, 1972. The report of the Examiner was filed with the Clerk of the King County Council April 19, with Motion No. 799.

SECTION 3. The legal description of the property designated is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map, designated Appendix B and is hereby made a part of this ordinance. The special permit topography plan is designated Appendix C and is hereby made a part of this ordinance.

SECTION 4. As provided for in King County Zoning Code Resolution No. 18801, as amended, the King County Council does hereby grant the special permit to allow removal of natural materials including a rock crusher described and shown in Section 3, Appendices A,B, and C above, and directs that Area Map No. W-7 be modified to so designate.

SECTION 5. This permit is granted subject to conditions adopted in Council Motion No. 799, and said conditions are incorporated herein as though fully set forth herein. Unless otherwise stated in said motion, the Division of Building
