2 AN ORDINANCE amending King County Zoning Resolution  
3 No. 25789, as amended, by amending the Zoning Map thereof  
4 reclassifying certain property thereon at the request of  
Sea & Ski Sports, Division of Land Use Management File  
No. 425-72-P

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

6 SECTION 1. Sea & Ski Sports petitioned on September 14, 1972, that the  
7 property described in Section 3 below be reclassified from RM-900 to C-G, and  
8 this application was assigned Division of Land Use Management File No. 425-72-P.

9 SECTION 2. The report and recommendation of the Division of Land Use  
10 Management was transmitted to the Zoning and Subdivision Examiner on October  
11 17, 1972, and hearing was held by the Examiner on the matter October 24, 1972.  
12 The report of the Examiner was filed with the Clerk of the King County Council  
13 on November 9, 1972, with Motion No. 1029.

14 SECTION 3. The legal description of the property to be reclassified is  
15 attached as Appendix A and is hereby made a part of this ordinance. The above  
16 described property is shown on the attached map which is designated Appendix B  
17 and is hereby made a part of this ordinance.

18 SECTION 4. The King County Council does hereby amend King County  
19 Zoning Code Resolution No. 25789, as amended, by reclassifying that property  
20 described and shown in Section 3, Appendices A and B above, to C-G and directs
