

ORDINANCE NO. 1907

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending Zoning Map thereof reclassifying certain property thereon at the request of SOOS COVINGTON PROPERTIES, Division of Land Use Management File No. 308-73-P

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. SOOS COVINGTON PROPERTIES petition on April 3, 1973 that the property described in Section 3 below be reclassified from SE and SR (Potential RM 900) to QM, and this application was assigned Division of Land Use Management File No. 308-73-P.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on June 12, 1973, and hearing was held by the Examiner on the matter June 19, 1973. The report of the Examiner was filed with the Clerk of the King County Council on July 5, 1973 with Motion No. 1223.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above to QM and directs




