

ORDINANCE NO. 1999

1 AN ORDINANCE recognizing \$312,826 of unan-
2 ticipated revenue from the Washington State
3 Department of Social and Health Services
4 and appropriating \$304,766 to the Mental
5 Health-Mental Retardation Fund, and \$8,060
6 to Program Budgets, Current Expense Fund.
7 Also appropriating \$56,436 to the Office
8 of Public Defense from the Involuntary Treat-
9 ment Services Division, Current Expense Fund,
10 amending Ordinance No. 1859, Sections 2 and 3,
11 as amended.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. King County hereby recognizes \$312,826 of unantici-
14 pated revenue from the Washington State Department of Social and Health
15 Services for involuntary treatment services in King County.

16 SECTION 2: An appropriation in the amount of \$304,766 to the
17 Mental Health-Mental Retardation Fund of which \$287,826 is for Crisis
18 Intervention Field Teams and \$16,940 for program evaluation, from Wash-
19 ington State Department of Social and Health Services, is hereby approved
20 and adopted.

21 SECTION 3: An appropriation in the amount of \$8,060 to Prog-
22 ram Budgets, Current Expense Fund, for program evaluation, from Washing-
23 ton State Department of Social and Health Services, is hereby approved
24 and adopted. The preliminary program evaluation shall be presented to
25 the King County Council by October 14, 1974.

26 SECTION 4: An appropriation in the amount of \$56,436 to the
27 Office of Public Defense from the Involuntary Treatment Services Division,
28 Current Expense Fund, for defense of involuntary treatment patients, is
29 hereby approved and adopted.

30 SECTION 5: Ordinance No. 1859, Section 2, as amended is here-
31 by amended to read as follows:






