

ORDINANCE NO. 2124

AN ORDINANCE calling a special election for the formation of Fire Protection District No. 50 in the vicinity of Skykomish, King County, Washington, declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. That the formation of a Fire Protection District will be conducive to the public safety, welfare and convenience, and will be of special benefit to the land included within the boundaries of such district, as hereinafter described.

SECTION 2. That the name and number of said district shall be King County Fire Protection District No. 50, the boundaries of which shall be as follows:

Beginning at the northwest corner section 3, T. 26 N., R. 10 E., WLM., thence southerly along the west section lines of sections 3, 10, 15, 22, 27, 34 to the southwest corner of section 34, T. 26 N., R 10 E., W.M., then east along the township line between Townships 25 N. and 26 N. to the King-Chelan County line, thence north along the King-Chelan County line to the King-Snohomish County line, thence west along the King-Snohomish County line to point of Beginning.

SECTION 3. That a special election be held on the 5th day of November, 1974, within the boundaries of the proposed district, as hereinbefore described, between the hours of 7:00 o'clock A.M. and 8:00 o'clock P.M., for the purpose of submitting to the qualified electors within the district the proposition of creating said Fire Protection District No. 50 and the election of three (3) Fire District Commissioners.

SECTION 4. That the following resident electors of said district are hereby named by the King County Council as candidates for election as the first Fire District Commissioners:

Paul Andreason, Baring, Washington 98224

Bernard Bertrand, Skykomish, Washington 98288

Paul Arrasmith, Box 237, Skykomish. Washington 98288

1 SECTION 5. That in submitting said proposition to the voters
2 for their approval or rejection, said proposition shall be
3 expressed on the ballot in the following terms:

4 KING COUNTY FIRE PROTECTION DISTRICT NO. 50 YES

5 KING COUNTY FIRE PROTECTION DISTRICT NO. 50 NO

6 SECTION 6. That the calling of the election, publication and
7 posting notices of same shall be done as required by law.


8 SECTION 7. The County Council finds as a fact and declares

11 for the support of county government and its existing public
12 institutions.




