ORDINANCE NO. 2284

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Ray J. Aliment, Division of Land Use Management File No. 253-74-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
